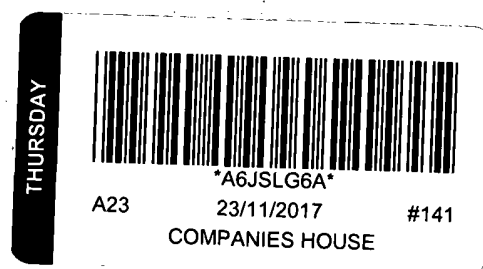

Business Review


