Directors' report for the year ended 31 March 2012

The directors present their annual report and financial statements for SpiriTel Networks Limited ("the Company"), for the year ended 31 March 2012

Principal activity

The principal activity of the Company in the prior year was the provision of telecommunication services to business customers in the United Kingdom. In February 2011 the Company sold its trade and assets to Daisy Communications Ltd, a fellow group company, and no longer continues to trade. The Company has been dormant during the year ended 31 March 2012.

Business review

The financial position of the Company is set out on page 6. The Company has no plans to trade in the future.

Results and dividends

The profit and loss account is set out on page 5. The Company did not make a profit or loss during the year. The directors do not recommend the payment of a dividend (2011: £nil).
