If on or before 31 December 2012 a winding up of the Company commences or there is a reduction or return of capital, the holder is entitled before payment of any sums for the Ordinary Shares, to be repaid the par value of the Deferred Shares.

If on or after 1 January 2013 a winding up of the Company commences or there is a reduction or return of capital and any distribution would result in the payment of at least £1,000 per Ordinary Share, the holders are entitled to the par value of their shares (or such lesser amount that may be available for distribution after the payment of £1,000 per Ordinary Share)
