The directors throughout the year were Harriet Mudekunye, Grace Muganguta and Patrick Ogwal Elor Norma Rossetto served until 31st January 2008 None of these directors received any payment during the year

The directors report a year with reduced activities. The financial constraints of the year have lessened the opportunity to serve HIV positive and AIDS sufferers in local groups and individual contacts. However there has been increasing interest in the Mercies of David website.

One volunteer has been going under training in anticipation of an increase in opportunities to serve

The opportunities of Mercies of David to contribute to AIDS/HIV awareness through education amongst youth and minority ethnic groups is apparent and we are planning future strategies for effective involvement in this area

The directors believe that the current objectives of Mercies of David meet the requirements of the Charities Act 2006 regarding demonstrable public benefit. Assistance is open to all sufferers from HIV/AIDS and their families without exception and at no cost. In providing this members of Mercies of David receive no private benefit.

Statement of Director's responsibilities

Company law requires the directors to prepare financial statements for each financial year which gives a true and fair view of the state of affairs of the company and of the profit or loss of the company during that period. In preparing those financial statements the directors are required to

Incoming Resources

Tax reclaims on Donations and Gifts

Incoming resources from tax reclaims are included in the SOFA in the same financial period as when the payment is received

Expenditure and liabilities

Governance Costs

Include costs of the preparation and examination of statutory accounts, the costs of the Directors' meetings and cost of any legal advice to Directors on governance or constitutional matters

Changes in Accounting policies and previous accounts

There has been no change to the accounting policies (variation rules and methods of accounting) since last year and no changes to the previous accounts

Grants payable without performance conditions

These are only recognised in the accounts when a commitment has been made and there are no conditions to be met relating to a grant which remain in control of the charity

Support Costs
