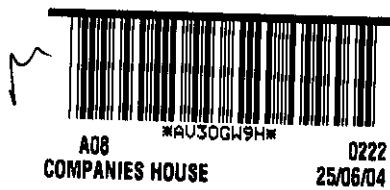

AUDIT EXEMPTION


The company has decided not to appoint auditors.


