

The company was placed into liquidation on 16 August 2012 and I was duly appointed Liquidator

An account of my receipts and payments for the period 16 August 2012 to 15 August 2013 is at Appendix B, together with a cumulative account for the entire period of the liquidation and a comparison with the Declaration of Solvency

3. Realisation of assets

As per the Declaration of Solvency sworn by the director on 16 August 2012, the assets of the company are an investment in a subsidiary totalling £2 The distribution of specie will be made shortly before closure

4. Creditors

I can confirm that I have not received any creditor claims during the course of the liquidation

5. Liquidator's remuneration

The Liquidator's remuneration has been determined in accordance with Rule 4 148A(2)(c) as a set amount, and has been paid separately by Santander UK plc

6. Liquidator's expenses

The only expense that has been paid during the period of this report is the Liquidator's bond which has been paid separately by Santander UK plc

7. Distributions

No distribution has been made to the members during the period covered by this report

8. Next report

I advise that the appropriate tax clearance has been sought from HM Revenue & Customs I am currently waiting to hearing back from them in regard to VAT clearance, which I expect to receive shortly I anticipate that a final meeting of members will be convened in accordance with Section 94 of the Insolvency Act 1986 within the next three months


