Directors' report

The directors present their annual report and the audited financial statements for the year ended 30 September 2003.

Principal activities

The principal activity of the company is steel stockholding. Throughout the year the company acted as an agent for Barrett Steel Limited. All transactions entered into have been transferred to Barrett Steel Limited in accordance with the terms of the agency agreement.

Dividends and transfers to reserves

The results of the company for the year are set out in the profit and loss account on page 5. The directors do not recommend the payment of a dividend for the year and, as a result of the transfer of all transactions to Barrett Steel Limited, the company made neither a profit nor a loss in the financial year.

Directors and directors' interests

The directors of the company who served throughout the year are shown on page 1.

Neither of the directors in office at the year end has any interest in the share capital of the company.

Mr J S Barrett and Mr P C Chasney are directors of the ultimate parent company, Barrett Steel Limited, and their interests in group companies are shown in the accounts of that company.

In accordance with Section 384 of the Companies Act 1985, a resolution for the re-appointment of KPMG LLP as auditors of the company is to be proposed at the forthcoming Annual General Meetings.

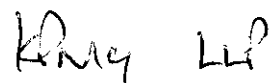
Basis of audit opinion

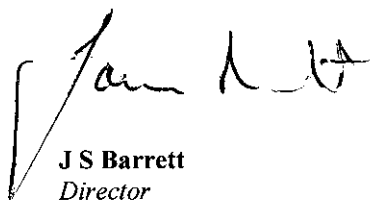

3 Contingent liabilities

The company is party to a multilateral-guarantee dated 29 June 2000 which secures all the borrowings of the group with HSBC Bank plc. At 30 September 2003, the maximum contingent liability arising under this guarantee was £5,800,000 (2002: £10,900,000).
