**INTRODUCTION**

The meeting of creditors took place at 11 00am on 5 March 2015 at Inquesta Corporate Recovery & Insolvency, St John's Terrace, 11-15 New Road, Manchester M26 1LS. A meeting of members was held at 11 15am on the same date. Both of these meetings were adjourned until Wednesday 11 March 2015 at 12 00noon.

The Nominee, Steven Wiseglass is the chairman of both the meeting of creditors and meeting of members.

**MEETING OF CREDITORS**

A list of Creditors attending or represented at the meeting is attached. It was noted that the meeting was quorate.

The creditors voted whether to approve the voluntary arrangement.

It was noted that those voting in favour of the resolution to approve the proposal exceeded the requisite majority necessary to pass the resolution, namely 75% or more in value of the creditors present in person or by proxy and voting on the resolution.

Since there were no votes against the approval of the proposal there was no requirement to hold a second round of voting.

The chairman declared that the resolution was passed unanimously and that the proposal for a voluntary arrangement was thereby approved. Accordingly the Nominee, Steven Wiseglass MIPA became the Supervisor of the Company Voluntary Arrangement, as outlined in the Proposal.

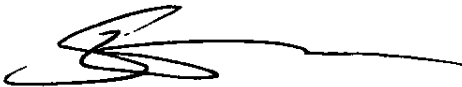
#### **MEETING OF MEMBERS**
