WHERE A LIQUIDATION COMMENCES PRIOR TO THE OCCURRENCE OF AN EVENT, ANY SURPLUS ASSETS AVAILABLE FOR DISTRIBUTION SHALL BE APPLIED AS FOLLOWS: (A) FIRST, IN ACCORDANCE WITH THE PROVISIONS OF ARTICLE 5.1.1.1(A); AND (B) THE BALANCE OF SUCH ASSETS (IF ANY) SHALL, AFTER BEING APPLIED IN ACCORDANCE WITH THE PROVISIONS OF PARAGRAPH (A) ABOVE BE DISTRIBUTED AMONGST THE HOLDERS OF THE A ORDINARY SHARES, B ORDINARY SHARES, C ORDINARY SHARES, D ORDINARY SHARES AND THE DEFERRED SHARES PRO RATA TO THE NUMBER OF SUCH SHARES HELD BY THEM PROVIDED THAT THE MAXIMUM AMOUNT TO BE PAID ON OR IN RESPECT OF A DEFERRED SHARE SHALL NOT IN ANY EVENT EXCEED £0.001. SAVE AS DESCRIBED IN THE ARTICLES AND SUBJECT TO THE PROVISIONS OF THESE ARTICLES, THE PROFITS OF THE COMPANY AVAILABLE FOR DISTRIBUTION AND RESOLVED TO BE DISTRIBUTED SHALL BE DISTRIBUTED AMONG THE A ORDINARY SHAREHOLDERS, THE B ORDINARY SHAREHOLDERS AND THE D ORDINARY SHAREHOLDERS. AT A GENERAL MEETING OF THE COMPANY ON A SHOW OF HANDS EVERY A ORDINARY SHAREHOLDER OR B ORDINARY SHAREHOLDER WHO (BEING AN INDIVIDUAL) IS PRESENT IN PERSON OR BY PROXY (NOT BEING HIMSELF A MEMBER) OR (BEING A CORPORATION) IS PRESENT BY A REPRESENTATIVE DULY AUTHORISED UNDER SECTION 375 OF THE ACT SHALL HAVE ONE VOTE ON A SHOW OF HANDS AND ONE VOTE ON A POLL.
