INDEPENDENT AUDITORS' REPORT TO THE MEMBERS OF IDEALSITE LIMITED.

We have examined the abbreviated accounts on pages 3 to 5, together with the annual accounts of Idealsite Limited for the year ended 30 April 2004. The scope of our work for the purposes of this report was limited to confirming that the company is entitled to the exemptions claimed in the directors' statement on page 2 and that the abbreviated accounts have been properly prepared from the annual accounts.

In our opinion the directors are entitled under sections 246 and 247 of the Companies Act 1985 to the exemptions conferred by Section A of Part 111 of Schedule 8 of that Act in respect of the year ended 30 April 2004 and the abbreviated accounts on pages 2 to 6 have been properly prepared in accordance with Schedule 8 to that Act.

As auditors of the company, we reported to the members on 16 November 2004 on the annual accounts prepared under section 226 of the Companies Act 1985 and taking advantage of the provisions of the Companies Act applicable to small companies for the year ended 30 April 2004 and our audit report was as follows:

"We have audited the financial statements for the year ended 30th April 2004, which comprise the profit and loss account, balance sheet and the related notes 1 to 10. These financial statements have been prepared on the basis of the accounting policies set out therein.

As described in the Statement of Directors' Responsibilities the company's directors are responsible for the preparation of the financial statements in accordance with applicable United Kingdom law and accounting standards.

Our responsibility is to audit the financial statements in accordance with relevant legal and regulatory requirements and United Kingdom Auditing Standards.

We report to you our opinion as to whether the financial statements give a true and fair view and are properly prepared in accordance with the Companies Act, 1985. We also report to you if, in our opinion, the Directors' Report is not consistent with the financial statements, if the company has not kept proper accounting records, if we have not received all the information and explanations we require for our audit. or if information specified by law regarding directors' remuneration and transactions with the company is not disclosed.

We read the Directors' Report and consider the implications for our report if we become aware of any apparent misstatements within it.
