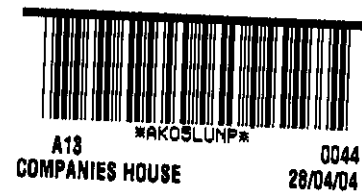


The Company was dormant throughout the financial period; although it carried out transactions as a nominee for another entity.
