

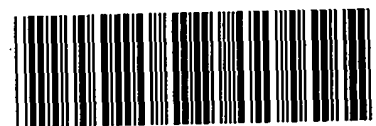

1. ACCOUNTING POLICIES

1.1. Basis of preparation of financial statements
