So as to promote the development of public appreciation of rhythm, dance, arts, crafts, the aural tradition and the wealth of the culture of Africa and the Diaspora, and in so doing provide training, skills sharing, cultural exchange and inspire celebration through participation and learning.

### Summary of the main activities undertaken for the public benefit

We have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing our aims and objectives and in planning our future activities

#### Summer 2010

Although the original wall painting that was by Stonebridge children as part of the Summer project 2008 was demolished as part of the regeneration of the local precinct. We are proud that Hillside Housing Trust organised the reproduction of the Mural, which is now hanging in full colour at the Stonebridge Centre, new Hub building

- We got a maximum attendance of 22 kids during the HHT summer art project. The kids produced
  excellent work, including a large painted tapestry 'Super Heroes' which was showcased to families at
  the end of the two week project. We look forward to continue building on this success in coming
  years.
- As part of Summer Uni 4U in RBKC we ran a successful drama and art project, 'Time Zones' at Response Centre, which included taking the young people on research trips to the V & A Museum, <u>Festivals Recordings/Documentation</u>
  - Abundance' band featured in Earls Court Festival and Lisson Grove Community Festival offering live exciting drumming dance and new interactive songs for the whole family
- Awards for All funded 'Feel the Rhythm' music and Wellbeing programme with Migrant Refugee Community Forum, MRCF The project was documented with a collection of songs on cd and DVD Black History Season 2010
  - ST Mary's Braynstone School gave Abundance Arts a special invitation to celebrate BHM with a whole school interactive storytelling assemble to inspire the children to look up to positive role models and aspire to their best
- St Mary Abbot school, Kensington invited Abundance Arts' Artistic director to judge and present awards for a special year 5/6 art completion, exploring Black Role models and historic figures Learner's week

Collaboration with inner City Pictures and Pepper Pot on 'Food For Thought Project' introducing digital photography combined with everyday sayings and proverbs, working with older participants. This included an Exhibition of work at the Tabernacle, Carnival Village

@ art project, 'The good, the bad and the ugly', interactive street art and photography project on Portobello road, with Inner city Pictures and Mutate Britain Exhibition

### Summary of the main achievements during the period Winter/Spring 2010

MRCF big get together party, Abundance performance added songs dance fun and energy

- We ran a successful drumming programme at Pimento after school club for 6months, which was supported by RBKC, the kids made a short sound recording to celebrate their learning
- Salusbury School's 'Ewasere' Drumming Ensemble (Abundance' young African drummers) were
  invited to play at the prestigious St John's Smith Square Westminster and Summerset House on the
  strand as part of Music for youth national festival
- Abundance Arts' Artistic director worked with Ground Work Uk Environmental charity devising and delivering music and storytelling workshops in schools that inspire and help educate students in taking practical steps on Climate Change issues

### Summer 2010

Hyde Pride Award and HHT support allowed us to run 6 weeks Saturday Kids Art Workshops in Stonebridge

- Abundance Arts performed with Ewasere at international day to help raise money for schools in Gambia
- Abundance' young drummers, Salusbury School, 'Ewasere', were chosen and played in Birmingham Symphony hall Part of Music for Youth National Festival, a notable achievement, documented on DVD, an exciting time for young participants, the school and family

I report on the accounts of the charity, which are set out on pages 6 to 11

### Respective responsibilities of trustees and examiner

The trustees (who are also the directors of the company for the purposes of company law) are responsible for the preparation of the accounts.
