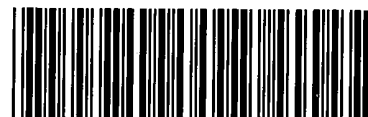

The Preference Shares do not entitle the holders thereof to receive notice of, attend or vote at general meetings or to vote on a written resolution of the company. Upon the winding-up or otherwise of the company (but not on any redemption of Preference Shares), the Preference Shares entitle the holders thereof to receive back the capital paid up on such shares in preference to any other class of share for the time being in issue together with a sum consisting of all outstanding arrears, accruals and deficiencies of the Preference Dividend and any accrued unpaid Preference Dividend on such shares, but do not entitle the holders to participate any further in the distribution of any surplus assets.
