ORDER

UPON the application of the Applicants by Notice of Application lodged on 3 AUGUST 2012

AND UPON reading the evidence of Mark Grahame Tailby

AND UPON the Respondent being neither present nor represented but having consented to the making of the Order set out below

AND UPON reading those documents recorded upon the Court file as having being read

IT IS ORDERED that -

- 1 In respect of the individual voluntary arrangements ("IVA"), company voluntary arrangements ("CVA") and voluntary liquidations listed in the Schedule to this Order which are the subject of proceedings in County Courts, those proceedings be transferred to the High Court solely for the purpose of making the Orders below
- 2 In respect of the individual voluntary arrangements, company voluntary arrangements and voluntary liquidations which are the subject of proceedings in the Royal Courts of Justice or a District Registry, those proceedings be transferred to the Leeds District Registry solely for the purposes of making the Orders below

- 3 The Respondent be removed from office as IVA Supervisor, CVA Supervisor, and Liquidator of the estates listed in the Schedule with immediate effect
- 4 The Respondent is replaced as office holder in the case of each of such estate in respect of which a proposed replacement appointee is named in the relevant column by that one of the Applicants named in the Schedule who is so appointed with immediate effect
- 5 In respect of the estates, the Applicants shall when the next routine report is due to the creditors of each estate, notify each creditor of the making of this Order or by written notice if earlier

Such notice is to contain the following matters

- 5 1 An explanation of the effect of the Orders
- 5 2 Express reference to the liberty to apply contained in paragraph 7 below
- 5 3 In the case of IVAs and CVAs, the provision of all such information as might reasonably be required as part of that report with regard to the conduct of the IVA and the CVA
- 5 4 In the case of liquidations the provision of all such information as might reasonably be required as part of that report with regard to the conduct of the liquidation
- 5 5 In the case of creditors voluntary liquidations under the Insolvency Act 1986 where liquidation committees have been appointed, an explanation as to the extent that any such information which would otherwise be required to be provided under Insolvency Rule 4 108(3) has not already been provided as part of the routine report, it is open to that Committee to require the Applicant appointed to provide an account of the administration of the estate including
 - 5 5 1 summary of receipts and payments
 - 5 5 2 a statement that he has reconciled his accounts
- 5 6 In the case of creditors voluntary liquidations under the Insolvency Act 1986, where no liquidation committee has been appointed an explanation that, to the extent that such information has not already been provided as part of the routine report, it is open to any creditor to apply to the Court for an Order that the Applicant appointed do provide such information as might otherwise be required by Rule 4 108(3) of the Insolvency Rules 1986, that is to say an account of the administration of each estate including

- 5 6 1 summary of receipts and payments
- 5 6 2 statement that they have reconciled their accounts
- 5 7 Notification that if any Applicant appointed has been required to provide the information referred to above, whether by the liquidation committee or by Court Order on the application of any individual creditors, the appointed Applicant's costs of so complying will, unless there are good reasons to the contrary, be paid as an expense of the winding-up as the case may be
- 5 8 In the case of liquidations under the Insolvency Act 1986 notification of each creditor of his right under Rule 11(2) (voluntary winding-up) of the Insolvency Regulations 1994 to require the appointed Applicant to supply a statement of receipts and payments free of charge
- 6 The Applicants be entitled to publish in the Gazette one composite notice relating to all new appointments which are required by law to be published in the Gazette
- 7 Liberty to each creditor of each estate to apply to vary or discharge this Order within 21 days of receipt of the notices directed to be sent under paragraph 5 above
- 8 The costs of the Application herein (including the VAT) be paid as an expense of each of the insolvency proceedings identified in the Schedule, the cost to be aggregated and apportioned equally amongst each of the said proceedings provided that
 - 8 1 if the costs which fall to be borne by any of the proceedings exceed 10% of the readily realisable assets within that proceeding then that proceeding shall only bear part of those apportioned costs that part being equal to 10% of that proceedings' readily realisable assets, and
 - 8 2 the excess shall then be apportioned and borne equally
- 9 Service of the said Notice of Application be dispensed with
