## **NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MARCH 2017**

### **1 STATUTORY INFORMATION**

Hemswell Residents Company Limited is a private company, limited by shares, registered in England & Wales. The company's registered number is 04080467 and registered office address is located at Preim Limited, Unit 8 The Forum, Minerva Business Park, Lynchwood, Peterborough, PE2 6FT.

### **2 ACCOUNTING POLICIES**

#### **Basis of preparing the financial statements**

These financial statements have been prepared in accordance with the provisions of Section 1A "Small Entities" of Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

### **3 ULTIMATE CONTROLLING PARTY**

In the opinion of the directors the company does not have one ultimate controlling party.

### **4 VOLUNTARY CHANGE IN ACCOUNTING POLICY**

The accounting policy for the statutory accounts for Hemswell Residents Company Limited has been amended for the financial period ending 31 March 2017 and dormant accounts have been prepared. This change in policy is to comply with RICS (Royal Institute of Chartered Surveyors) guidance on accounting for service charge income.

As the service charge fund is held in trust for the contributors to the fund, it is not a part of the assets of the residents company and should not therefore be shown in the balance sheet. Equally the income and expenditure relates to the fund and not to the residents company, therefore dormant accounts are applicable.

The statutory accounts for the period ending 31 March 2017 show prior year comparatives that were prepared under the special provisions of Part 15 of the Companies Act 2006 relating to small companies.

Income and expenditure into and out of the service charge fund for the accounting period is fully disclosed in the audited service charge accounts.
