

Notes to the financial statements

1. Accounting policies

The financial statements of the company have been prepared under the historical cost convention and in accordance with applicable UK accounting standards. The bases used are consistent with those used in the previous year.

Basis of preparation

The company is a wholly owned subsidiary of Diageo plc and is included in the consolidated financial statements of Diageo plc which are publicly available. Consequently the company has taken advantage of the exemption from preparing a cash flow statement under the terms of Financial Reporting Standard No 1 (Revised 1996).

The company is exempt under the terms of Financial Reporting Standard No 8 from disclosing related party transactions (but not balances) with entities that are part of the Diageo plc group ("group undertakings") or investees of the Diageo plc group.

The company acts as a trustee and nominee for the purposes of administering the Diageo Sharestore. As at 30 June 2007 the Diageo Sharestore held 13,149,388 ordinary shares in Diageo plc for the beneficial ownership of employees of the Diageo group. The directors foresee no changes in the company's activities.

2. Profit and loss account

None of the directors received any remuneration during the financial year in respect of their services as directors of the company (2006 - £nil).
