

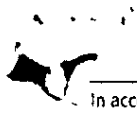

The Main Subject Matter of this Mortgage

1. The Property and other assets
