

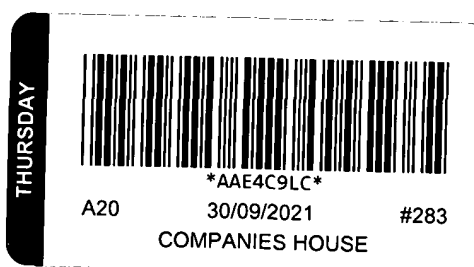

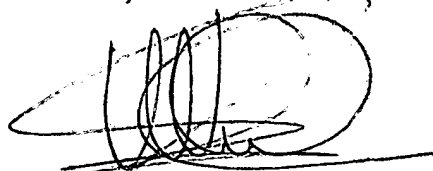

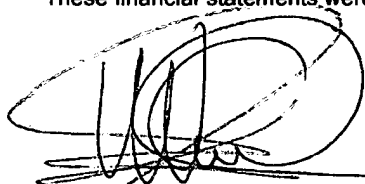

1. Basis of accounting and significant accounting policies

Statement of compliance

The financial statements of the Company have been prepared in accordance with International Financial Reporting Standards (IFRS) and International Accounting Standards (IAS) and their interpretations as endorsed by the EU and effective at 31 December 2020. No standards published by the IASB but not yet adopted by the European Union at 31 December 2020 have been applied in anticipation. No significant effect is expected from the future application of these standards.

Basis of preparation and presentation

The financial statements are presented in sterling. They are prepared under the historical cost convention.

There are no judgements or estimates made by management in their application of IFRS that could have significant effects on these financial statements.

The company had no transactions during the year and has made neither a profit nor a loss. No Income statement has therefore been prepared.
