Sunderland, Tyne and Wear, SR5 3JN (**Receivers**)

**Recitals**

- (A) By a debenture dated 20 April 2001 and registered at Companies House on 10 May 2001 between (1) Northern Precision Engineering Limited (**Borrower**) and (2) the Lender various assets were charged by way of legal mortgage and associated fixed charges (comprised at paragraphs 3.1.1 to 3.1.3 (inclusive) of the Debenture for securing the payment to the Lender of the Secured Liabilities (defined therein)
- (B) In addition to the powers contained in schedule 1 of the Insolvency Act 1986, the Debenture provided that the Lender should have the power to appoint a receiver or receivers in respect of the assets charged by the Debenture and have the powers more particularly set out in the Debenture
- (C) The Secured Liabilities secured by the Debenture have become due and payable and the powers of appointing a receiver or receivers pursuant to the Debenture have become enforceable. Those powers have now become immediately exercisable in respect of the Debenture and the Lender wishes to exercise such powers by making the appointment herein

**It is agreed**

**1 Appointment**

The Lender being the registered holder of the Debenture in pursuance the power conferred on it by the Debenture and of every power conferred upon him by statute or otherwise appoints, the Receivers to be joint administrative receivers of all the undertaking, property and assets of the Borrower charged by the Debenture upon the terms and with all the powers confirmed by the Debenture or by law or

otherwise and so that either of the Receivers may exercise any such power independently of the other




