DIRECTOR'S REPORT

It was agreed by the Directors that Mr. Stephen Waldenberg would take over from Dr. Kurt Simon as Secretary of the Management Company during 2019.

Overall expenditure for the year 2018 increased by 78.4% to £5,768.91 compared to £3,233.10 in 2017 which resulted in an excess of expenditure over income of £2,168.91 for the year. This large increase in expenditure was voted at Item 3 of the AGM held on 3 August 2017 for external painting, gutter clearance and pathing stone levelling. This was slightly offset by reductions in expenditure for basic garden maintenance of 8.7% (£110.00) and a large reduction in Green Thumb lawn treatment of 60.1% (£244.00) due to lawn scarification not being carried out in 2017.

This excess of expenditure over income reduces reserves to £665.90. The Directors have therefore decided to set the Service Charge for 2019 at £900 per Director in order to increase reserves.
