AUDITORS

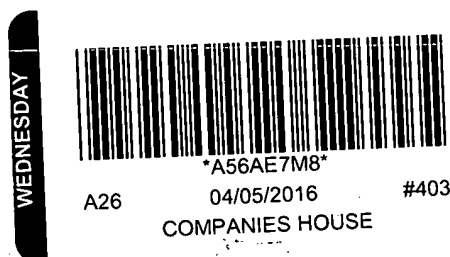

STATEMENT OF DIRECTORS' RESPONSIBILITY

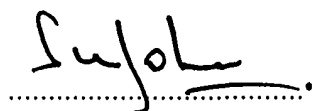
Opinion on other matter prescribed by the Companies Act 2006
