STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing Document

The organization is a charitable company limited by guarantee, incorporated on 20 March 2001 and registered as a charity on 23 May 2001. The company was established under a Memorandum of Association which set out the objects and powers of the charitable company and is governed by its Articles of Association. In the event of a winding up of the company, members are required to contribute an amount not exceeding £1.

Recruitment and Appointment of Trustees

The directors of the charitable company ('the charity") are its trustees for the purposes of charity law and throughout this report are collectively referred to as trustees. The trustees serving during the year and since the year end are set out above on page 1.

As set out in the Articles of Association the trustees are members of the Board which shall consist of not less than three members. At each Annual General Meeting the trustees shall retire from office. Retiring trustees are eligible for re-election unless the Annual General Meeting shall decide that trustees who have a certain number of years service must stand down for at least twelve months before being eligible to stand again.

A chairperson is elected each year at the first trustees' meeting after the Annual General Meeting and that person presides over the meetings of trustees which take place every two months.

All trustees, who give their time voluntarily and receive no benefits from the charity, are recruited from user groups and volunteers and those who have an interest in the provision of a community transport system.

The charity is extremely fortunate to have a Board which has served for long enough to know the history of the charity, how it works and the financial challenges. That experience is invaluable and the chairman greatly appreciates the advice and support, astuteness and commitment that each member brings to the Board.

No honorary office may hold the same position for more than five years.

AIMS AND OBJECTIVES

Objectives

The charity's purposes, as set out in the objects clause of the Memorandum of Association, are to provide relief to the inhabitants of the London Borough of Enfield who have need because of age, mental or physical disability or poverty and in particular provide and maintain a non-profit community transport service and to assist the charitable work of organisations engaged in promoting the relief of such persons.

Enfield Community Transport exists to provide a quality service to all community groups within the London Borough of Enfield. Eleven of the thirteen minibuses in the organisations fleet are equipped with tail-lifts to enable wheelchair users and persons less able to access the vehicles. In addition to these, the organisation also has available three smaller wheelchair accessible vehicles for single occupancy. These vehicles enable persons caring for others to access transport that would otherwise be denied due to cost and availability.

How our activities deliver public benefit

The main activity of the organisation is to provide safe, accessible and affordable transport to its member groups to attend social and luncheon clubs, day centres, clinics and evening meetings. Day and weekend trips are also undertaken to allow some groups their only opportunity of visiting the country or seaside.

We currently have sixteen vehicles in our fleet, fourteen of which are equipped with a tail lift or vehicle ramp to accommodate person in wheelchairs.

Of the 1,514 journeys undertaken during the year 2014-15, approximately 78% were carried out by a team of unpaid, dedicated volunteer drivers, the remaining 22% being made by drivers nominated by member groups.

The majority of the groups which use our services cater for the elderly, people with disabilities and who are vulnerable and therefore unable to use conventional transport systems. The driver will collect each person from their home and deliver them back to their front door and see them safely inside, thus avoiding any feeling of vulnerability on the part of the passengers, particularly after dark. The journeys encourage social contact between passengers themselves, and the passenger and the driver. This is particularly important and helpful for those with learning and emotional difficulties as the number of passengers is small and the vehicle itself provides a safe travel environment.

Volunteers and staff

We have said on many occasions that the organisation would not exist if it were not for the dedication and commitment of the volunteer drivers and we cannot thank them enough or praise them too highly for what they do in sometimes quite stressful situations. Volunteers are the vital link within the organisation, without whom a great many residents in Enfield would simply be housebound.

FINANCIAL REVIEW

Review of the Financial Position

The results for the year are set out on pages 6 to 13.

The trustees are mindful of the financial viability of running a vehicle the fleet and balancing the need to maintain and replace them whilst ensuring the appropriate working conditions for all volunteers and paid staff.

As a charity the trustees cannot make a profit but must operate as a business and meet the running costs of an office, salaries and the maintenance and repair of vehicles. The trustees will, of course, keep charges in line with operational costs. With this in mind there is a review of charges on an annual basis.

Principal Funding Sources

The London Borough of Enfield continue to provide a major and critical grant to the charity. The Board would like to thank them for their support and are mindful that without such support the charity simply could not continue its level of service to the people of Enfield.

The trustees review regularly the source of funds to provide the service and are mindful of the fact that a major part of the necessary resources is provided by the local authority. The Trustees are constantly striving to maintain the quality of the service and they are confident that as long as the standard of the service is maintained, the local authority will continue to support the organisation.

Reserves and Risk Policy

The trustees regularly review the level of reserves maintained, which represent unrestricted funds not committed or invested in tangible fixed assets. The aim is to maintain reserves at a level to ensure that should there be a reduction in income that the service could continue for between three and six months at current rates of expenditure.

The trustees actively review the major and business risks faced by the organisation. Issues and concerns are discussed at trustees meetings and procedures are in place to ensure that concerns are addressed.

Plans for the Future

The key plans for the future are:

- To constantly review and update risk, reserves and other policies to ensure the effective management of the organisation.
- To explore the possibilities of raising awareness of Enfield Community Transport and its services.
- To consolidate on the past success of the organisation and seek the views of users on how we can improve the services provided or which service they would like to include within Enfield Community Transports remit.
- To develop a range of different services for other users and organisations in the borough. These are currently under review and will form part of our budget for 2015-16.

Responsibilities of the Trustees

Rodin Chair

The trustees, (who are also directors of Enfield Community Transport for the purposes of company law), are responsible for preparing the Trustees' Annual Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Company law requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charitable company and of the incoming resources and application of resources, including the income and expenditure, of the charitable company for that period. In preparing these financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charities SORP;
- make judgements and estimates that are reasonable and prudent;
- state whether applicable UK Accounting Standards have been followed, subject to any material departures disclosed and explained in the financial statements; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charitable company will continue in business.

The trustees are responsible for keeping adequate accounting records that disclose with reasonable accuracy at any time the financial position of the charitable company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

The trustees' report is prepared in accordance with the special provisions of Part 15 of the Companies Act 2006 relating to small companies.

INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF

ENFIELD COMMUNITY TRANSPORT

I report on the accounts of the charity for the year ended 31 March 2015, which are set out on pages 6 to 13. This report is made solely to the charity's trustees, as a body, in accordance with Section 145 of the Charities Act 2011. My work has been undertaken so that I might state to the charity's trustees those matters I am required to state to them in this report and for no other purpose. To the fullest extent permitted by law, I do not accept or assume responsibility to anyone other than the charity and the charity's trustees as a body, for my work, for this report, or for the opinions I have formed.

Respective responsibilities of trustees and examiner

The charity's trustees (who are also the directors of the company for the purposes of company law) are responsible for the preparation of the financial statements. The charity's trustees consider that an audit is not required for this year under Section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed and I am qualified to undertake the examination by being a qualified member of the Association of Chartered Certified Accountants.

Having satisfied myself that the charity is not subject to audit under company law and is eligible for independent examination, it is my responsibility to:

- examine the financial statements under Section 145 of the 2011 Act;
- to follow the procedures laid down in the General Directions given by the Charity Commissioners under Section 145(5)(b) of the 2011 Act; and

Basis of independent examiner's report

1. ACCOUNTING POLICIES

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the period.

(a) Basis of accounting

The financial statements have been prepared under the historical cost convention and in accordance with the Companies Act 2006, the Statement of Recommended Practice - Accounting and Reporting by Charities issued in 2005 and the Financial Reporting Standard for Smaller Entities (effective April 2008).

(b) Fund accounting

Unrestricted funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity. The trustees have the discretion to designated some of the unrestricted funds to be used for specific purposes such as to fund replacement vehicles.

Restricted funds are subjected to restrictions on their expenditure imposed by the donor.

(c) Incoming resources

All incoming resources are included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

- donations are included in the accounts when they are received;
- vehicle hire is accounted for in the period in which the income is earned;
- grants are recognised over the period to which they relate when known;
- investment income is included when receivable.

(d) Volunteers and donated services and facilities

No value is incorporated into these financial statements for the services provided by volunteers or where services are provided to the charity as a donation.

(e) Resources expended

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates.

Costs of generating funds comprise the costs associated with attracting voluntary income.

Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity and include the independent examiners fees.

(f) Tangible fixed assets

Fixed assets are stated at historical cost less accumulated depreciation. Depreciation is provided on all tangible fixed assets at rates calculated to write off the cost of each asset over its estimated useful life which is for all classes of asset 25% of its reducing balance.

An item is treated as a fixed asset if it can be used for more than one year and cost at least £500.
