1 INTRODUCTION

It is now over one year since my appointment as Liquidator and I submit my annual progress report for your information. This report and financial information is supplementary to any earlier reports

2 BACKGROUND

APPOINTMENT DETAILS

Jonathan Paul Philmore was appointed Liquidator of Blacksmith DC Limited on the 23 December 2014

The members' and creditors' meetings were held on 23 December 2014

The nature of the Company's business was that of Design Consultancy Services

The main causes of failure were -

- A reduction in turnover and difficult trading conditions
- · An inability to maintain contributions to a CVA
- Being issued with a Notice of Breach which was incapable of being remedied

3 ASSET REALISATIONS

The Liquidator's Receipts and Payment account for the period 23 December 2014 to 22 December 2015 is attached at Appendix 1

According to the statement of affairs lodged in these proceedings, the assets of the Company comprised of outstanding book debts, office furnishings and equipment and an overdrawn director's loan account

BOOK DEBT

As at the date of my appointment the Company was owed the sum of £3,436 00 I have recovered the sum of £1,088 50 and no further realisations are expected

Furniture & Equipment

The Company's office furniture and equipment was valued by my agents Michael Steel & Co of Leeds at £650 00 The items were sold by my agents to a connected company for £650 00 plus VAT

Director's Loan Account

The Company's accounts to 31 August 2013 showed an overdrawn loan account in the sum of £142,803 Following my appointment as liquidator I requested the director's proposals for the repayment of his loan account

The director has provided me with substantive documentation showing payments made on behalf of the Company between 1 September 2013 and 28 November 2014 which total in excess of £150,000. As such I am satisfied that the loan account has been repaid in full

4 INVESTIGATION

The directors conduct report was submitted to the Insolvency Service on 13 April 2015 The contents of this report are confidential and not available for circulation to creditors

I have concluded my enquiries into the Company's affairs and no matters have come to my attention that would require me to make any further investigations into the Company's acts and dealings

5 CREDITORS CLAIMS

Creditor claims as per the directors' estimated statement of affairs totalled £215,894 The claims were broken down as to HM Revenue & Customs for unpaid VAT of £18,509 & CT/PAYE/NIC of £54,673 Trade creditors amounted to £26,729 and an associated company was owed £76,000

Total claims received to date total £123,597 53

6. DIVIDEND PROSPECTS

Secured Creditor

There are no secured creditors in this matter

Dividend in Relation to the Prescribed Part

Under the provisions of Section 176A of the Insolvency Act 1986 the Liquidator must state the amount of funds available to unsecured creditors in respect of the prescribed part. This provision only applies where the Company has granted a floating charge to a creditor after 15 September 2003. The charge registered against the Company was created in September 2001 and as such the provisions of this Section do not apply.

Liquidator's Remuneration

Summary of Costs

The Liquidator's time costs for the period 23 December 2014 to 22 December 2015 totals £4,877 40. No fees have been drawn to date and given the level of realisations in this matter my firm's time costs and future time costs will be written off.
