

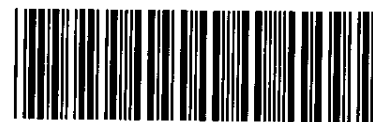

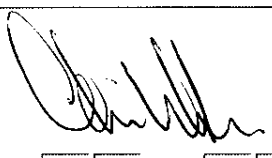

As Joint Liquidator, I am required to meet a considerable number of statutory and regulatory obligations. Whilst many of these tasks do not have a direct benefit, they assist in the efficient and compliant progressing of the liquidation, which ensures that I and my staff carry out our work to high professional standards.

6. CREDITORS CLAIMS & DIVIDEND

Unsecured creditors

Further to the Corporation Tax liability of £5,581.79, which paid during the previous Review Period, HMRC made us aware that statutory interest remained unpaid on this amount. During the current Review Period, the Joint Liquidators paid £90.53 in respect of Statutory Interest as per HMRC's request.

Further to previous correspondence from HMRC regarding National Insurance contributions, it was confirmed that a PAYE scheme was created erroneously by HMRC and has since been closed, with all penalties revoked. The Joint Liquidators are still awaiting written confirmation of the above to enable the closure of the liquidation.

7. COSTS AND EXPENSES

The payments shown on the summary of the Receipts and Payments at Appendix I are self-explanatory.

Joint Liquidators' Remuneration

The Joint Liquidators remuneration was approved on a fixed fee basis in relation to this assignment as authorised by the passing of the following written resolution by the members of the Company on 21 October 2017:

"An ordinary resolution that the remuneration of the Joint Liquidators be fixed at £2,500 plus Vat and disbursements. This amount assumes that no undue complications arise, also that all accounting information up to the date of liquidation is readily available. If time costs exceed the fixed amount due to unforeseen problems it is resolved that the Joint Liquidators will seek authority from the members to charge additional fees on a time cost basis by reference to the Opus Restructuring LLP scale of charges."

Summary of Costs

The Joint Liquidators time costs for the Review Period are shown at Appendix 2. The sum of £2,500 has been paid in accordance with the above written resolution and the remaining time costs will be written off.

Joint Liquidators' Disbursements

The Joint Liquidators category 1 disbursements incurred during the Review Period total £3.99, are detailed at Appendix 2 and represent the simple reimbursement of actual out of pocket payments made on behalf of the assignment.

The Joint Liquidators category 2 disbursements for the Review Period total £4.60 which may include an element of overhead charges in accordance with the resolution passed by members on 21 October 2017. The basis of calculation of this category of disbursement was disclosed to members prior to the resolution being passed and is also detailed at Appendix 2.

8. SHAREHOLDERS DISTRIBUTIONS

There were no distributions made during the Review period.

9. FURTHER INFORMATION

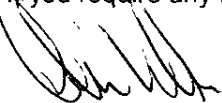
