UPON THE APPLICATION of the Applicants for block transfer orders under Chapter 6 (Sub-division B) of Part 12 of the Insolvency (England and Wales) Rules 2016

AND UPON hearing the solicitor for the Applicants

IT IS ORDERED THAT:
