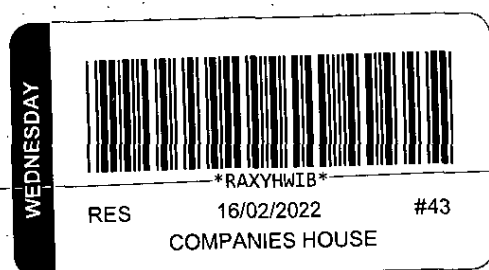

5. The Registrar of Companies do advertise notice of this Order in her official name in the 'London Gazette'
