BEFORE DISTRICT JUDGE SMITH sitting in Manchester on 16<sup>th</sup> December 2011

UPON the application of Arthur Custance

AND UPON reading the evidence

IT IS ORDERED THAT

- 1 In respect of those Creditors Voluntary Liquidations and Compulsory Liquidations identified in the Schedules attached to this Order (the "Schedules") as being the subject of proceedings in the various County Courts specified in the Schedule, those proceedings be transferred to the High Court Division, solely for the purpose of making the Orders contained in the paragraphs below and thereafter be transferred back to the relevant County Court.
- 2 The following removals and appointments take place with immediate effect
  - 2.1 Arthur Custance be removed from office as Liquidator of the companies in Voluntary Liquidation listed in Schedule 1 attached hereto pursuant to Section 171(2) of the Insolvency Act 1986, with effect from 20 December 2011 and

Michael Leslie Reeves be appointed as Liquidator in substitution in respect of the said companies with effect from the same date pursuant to Section 171 of the Insolvency Act 1986

2 2 Arthur Custance be removed from office as Liquidator of the company in Compulsory Liquidation listed in Schedule 2 attached hereto pursuant to Section 172(2) of the Insolvency Act 1986, with effect from 20 December 2011 and Michael Leslie Reeves be appointed as Liquidator in substitution in respect of the said company with effect from the same date pursuant to Section 172 of the Insolvency Act 1986

- 3 The Respondent shall within 28 days of the date of this order publish in the Gazette one composite notice relating to all new appointments effected hereby and shall file any appropriate notices in respect of the Applicant's removal and those appointments with the Registrar of Companies and the Secretary of State for Business, Innovation and Skills (Insolvency Service) as appropriate
- 4 The Applicant shall be granted his release as appropriate 21 days after the publication in the Gazette referred to above.
- 5 The Respondent shall, when the next routine report is due to the creditors/members of each Creditors Voluntary Liquidation and Compulsory Liquidation, give written notice of the making of this order to each such creditor/member
- 6 Liberty to each creditor/member of each liquidation, voluntary arrangement, administration and bankruptcy to apply to vary or discharge this order within 28 days of receipt of the notices directed to be sent under paragraph 5 above
- 7 Service of Notice of the Application upon the Respondent be abridged
