#### 3 Prospects for Creditors

#### 3.1 Secured Creditor

The secured creditor is Barclays Bank Plc. secured by a fixed and floating charge on each company (including other companies within the group) with cross guarantees. The secured creditor has been paid £2.488.928 across the companies and is due no further monies.



#### 3.2 Preferential Creditors

The employment of all employees of the companies transferred to the purchaser of the business. Redwood Group Limited under the Transfer of Undertakings (Protection of Employment) Regulations 2006 (known as 'TUPE'), and as such there are no preferential claims in the administrations
