- Group 4 (19-21 months, n=10):** Starts at approximately 10% on trial 1, rises to 30% on trial 2, 50% on trial 3, 70% on trial 4, and ends at 90% on trial 5.
- Group 5 (22-24 months, n=10):** Starts at approximately 10% on trial 1, rises to 30% on trial 2, 50% on trial 3, 70% on trial 4, and ends at 90% on trial 5.




