General company information

The Company is a private limited company limited by share capital incorporated in England and Wales. The address of its registered office is Shell Centre, London, SE1 7NA, United Kingdom.

1. Accounting policies

a) Basis of preparation

These financial statements have been prepared in accordance with FRS 101, which involves the application of International Financial Reporting Standards ("IFRS") with a reduced level of disclosure.
