The Company had no known creditors A notice to creditors to prove their claims in the liquidation was advertised in The London Gazette newspaper on 23 December 2014 No creditors were forthcoming as a result of this advertisement

Searches of the Index of Proprietors Names at HM Land Registry (in the Company's present and former names) proved negative

Tax

All pre-liquidation corporation tax matters were handled by WPD who prepared and submitted all outstanding returns up to the date of the commencement of the liquidation to HM Revenue & Customs ("HMRC") At the request of the Joint Liquidators, HMRC subsequently confirmed that the Company had no outstanding corporation tax returns or liabilities, that it would not raise enquiries into any pre or post liquidation periods and that it had no objection to the Liquidators calling a final meeting of members to conclude the liquidation

A similar assurance was sought and received from HMRC in respect of PAYE and VAT matters

Distributions

There were no assets available for distribution to shareholders

Joint Liquidators' remuneration and expenses

A written resolution was passed on 9 December 2014 that the remuneration of the Joint Liquidators be fixed at their normal charging rates according to the time properly spent by them and members of their staff in attending to matters arising in the winding up of the Company
