Trustees' Report

STRUCTURE, GOVERNANCE AND MANAGEMENT

Organisation

The Charity is governed by an Executive Committee of Trustees who are appointed by the Charity's members, and who act as Directors of the Company. Its core activities and projects are managed by a non-trustee Project Director, with a staff team of 4 full time, 5 part time, 8 sessional staff and 3 volunteers, reporting to the Executive Committee.

Appointment of Trustees

At an Annual General Meeting of members one third of the Trustees are required to retire, but may offer themselves for re- election.

History of the Charity

The charity began life in 1996 when a group of parents who attended Holly House Child Development Centre in Rishton formed a self-help group which they subsequently established as a registered charity called CASSEL (Children with Aspergers Syndrome Support in East Lancashire). In 2000 the charity changed its name to Action for ASD (Autistic Spectrum Disorders) to reflect its extended scope, and in 2001 it was fortunate enough to win funding from the Big Lottery. A new incorporated charity (ie: charitable company) was then formed, also called Action for ASD, to take on the role of employing a small team of staff, to develop the project and offer more help to families whose lives were affected by Autistic Spectrum Disorders.

This funding helped to put Action for ASD on the map and it has grown steadily over the years. From humble beginnings in a small office with a staff team of 4, it has grown and is now based at the ARC (Autism Resource Centre) at Kings Mill, Harle Syke, Burnley.

The charity began its life supporting parents who had children with a high-functioning Autism or Asperger Syndrome. The major functions of the charity at this stage were to support parents, provide training, raise awareness and provide family social events so families could develop relationships and support each other.

As often happens when an organisation becomes successful and grows, the remit of the charity widened and we began to provide some respite through social and leisure opportunities for young people with Asperger Syndrome. As we did not have the facilities or resources at this stage, the charity hired a Learning Disability Day Service to provide youth clubs and Saturday Clubs for children aged 8 – 19 years. We then found that parents and carers were asking for a wider range of activities, which was impossible to provide at the Day Centre as it was used during the day by Lancashire County Council.

The Project Director then began the mission to raise funding and to search for a suitable building, so that Action for ASD could have its own one stop shop Resource Centre with play facilities for the children but one which could also house services to support parents and carers too. By February 2007 this was accomplished and the charity moved into Kings Mill, Queen Street, Burnley, Lancashire. Since February 2007 the charity has gone from strength to strength and we now have a fully functioning Autism Resource Centre (ARC) in over 10,000 sq ft. space.

Action for ASD now provides Children's Services and Adult Services from the ARC and is funded by East Lancashire NHS, Blackburn with Darwen NHS, Lancashire County Council, Children in Need and Three Guineas.

The facilities Action for ASD now have at the Autism Resource Centre are; Offices, Resource Library, Games Console Zone, Soft Play structure, Bouncy Castle, Toddler Area, Subbuteo Table, Air Hockey, Table Tennis, Snooker/Pool, Kitchen and Tuck Shop, Café area, Sensory Room, Music Room, Arts and Crafts, Cinema Facilities, Internet Café, Water and Sand Play, Parents Meeting Place and many other resources for the children and adults to access at the play sessions.

Public Benefit

The trustees confirm that we have paid due regard to the Charity Commission guidance on public benefit reporting in deciding what activities the charity should undertake.

The remainder of this Annual Report explains the charity's work during the year and how it has been carried out for the public benefit.

OBJECTIVES AND ACTIVITIES

Mission Statement

Action for ASD exists to make a difference to the lives of those with Autism Spectrum Disorders in East Lancashire and to support their families and carers.

The Charity's objectives

- To relieve those persons who are diagnosed with autistic spectrum disorders by the provision of support, advice, information and assistance to those individuals with autistic spectrum disorders, their families and carers and associated professionals.
- To increase public awareness regarding the difficulties and circumstances of people with autistic spectrum disorders and their families and carers and to encourage acceptance within the community.

What does Action for ASD do?

The Autism Resource Centre is the only specialist provision in the East Lancashire area offering support services, respite and leisure and recreational opportunities for children, young people and adults with an Autistic Spectrum Disorder (ASD).

Action for ASD has been successful in developing a number of different services and projects and can offer a comprehensive support framework from pre diagnosis and beyond for both children and adults. The group has a strong membership from individuals with a diagnosis of ASD, their families, carers and members of the professional network in the East Lancashire and Blackburn with Darwen area (Adults services).

With the right support people with Autism can live meaningful and productive lives. Action for ASD strives to provide such support. The services we provide are:

Children's Services

	IMPACT Project – A social and leisure project for young people aged 4 – 19 years. The project also offers advice and support to young people, families and professionals. Fun and Play Sessions are held throughout the week and all day on a Saturday during term time. These sessions offer children a chance to play and meet other young people whilst giving their parents a well-deserved break.
0	Family Play Sessions – An opportunity for family members to relax and meet other families in a safe ASD environment.
	Summer and Holiday Activity Programme for children and young people of all ages (4-19 years) with a diagnosis of ASD. Activity sessions are held every day during school holidays and we provide a wide range of fun, age appropriate activities in a structured programme throughout the week.
	Guidance and specialist advice on Autism and related fields.
	Conferences and training seminars, offering parents, individuals and professionals an opportunity to learn about Autistic Spectrum Conditions and related topics.
	Quarterly Newsletter containing local and national information relating to ASD.

Social events and outings.
Adult Support Group — This is a support group which meets every weeks and is a group for adults with a diagnosis of Asperger Syndrome.

Counselling - Post Diagnosis and Specialist Counselling Service.
Adult Education – Working in Partnership with Burnley College the Adult Service can provide

ACHIEVEMENTS AND PERFORMANCE

Children's Services

Short Breaks for Children and Young People

Due to circumstances out of our control the funding from Lancashire Break Time was not in place from the start of the year (April 2013), funding was provided sporadically over the year but this meant over the course of the year there were some gaps in the full provision previously provided.

Through slightly increasing charges and reducing the number of sessions at times Action for ASD were able to continue to provide play sessions throughout the year as much as possible with budgetary constraints, using small amounts of funding from other sources. We were however fortunate to be given full funding for the summer holidays from LBT and full funding was re-established for weekdays and weekends in November 2013 for weekdays, weekends and holidays up to March 2014. Over the year Action for ASD provided 211 Short Breaks sessions over the year for 110 children with an Autistic Spectrum Condition.

Holiday Programme

For the fourth year running we were fortunate enough to receive funding for all the school holidays for children aged 4-18 years throughout the year. This included all half terms, Easter and the 6 week summer holidays. A fun programme of activity days was offered and included, Robin Wood Activity Centre, Wacky Science Workshops, Dinosaurs, Art and Crafts, Construction Club, Arts and Crafts, Pottery, Cookery Club, alongside all the other activities offered at sessions on a regular basis. Over the course of the year the Holiday Programme provided short breaks for 61 children over 51 full days of Holiday provision.

Transition Group

The Transition Group is held every Thursday night and has a group of 10 regular members whose ages range from 16-25 years. The young people who attend the transition group enjoy playing pool, table tennis, air hockey and games consoles. The transition group works well in introducing young adults to the adult service. It is a safe and comfortable environment for them to talk about college, university, exams and what happens next during the journey into adult services.

Common discussion themes during the group have been shaving, personal hygiene, bullying, conversation skills and how to stay safe on the internet.

Parents' Services

Parent Support Group

The parent support groups are held the first Thursday of the month. This is a great opportunity for parents and carers to come together for refreshments, to support each other, make friends and share information and advice. During the year we have had various speakers who have attended the sessions to help parents on a variety of topics. These are popular sessions and we hope to continue with these in the new financial year.

Family Sessions

On a Monday evening Children's Services have held our Family sessions for children with Autism and their siblings. These sessions are funded by Children In Need. These sessions have allowed parents and carers the opportunity to socialize, share experiences and information with each other. These have been well attended by 53 families during the 40 sessions during the year.

These sessions are fully staffed and parents can bring along their children with autism and their brothers and sisters, who will all be looked after by trained knowledgeable staff in a safe environment. Parents have the choice to leave their children and have a break from caring or they can use our café area to socialise and meet other parents and carers who can share life experiences and provide mutual support.

Parent Support

The Children's Services Manager continued to provide emotional and practical support to parents. Many parents need support on various subjects such as diagnosis, challenging behaviour, school issues and they can access this support either at sessions or on a one to one basis at the Autism Resource Centre. There is always a huge demand for this service and Action for ASD will need to secure more funding in order to provide a more comprehensive and resourced service for the increasing numbers of parents who want to access this service.

Girls Group

In the last 12 months Action for ASD has developed its girls group; the group has been running monthly during one of our Senior Impact Clubs. There are now 12 members of our girls group aged 8-18 years that attend the session regularly.

The group has been based around craft activities and socialising. The girls have enjoyed a variety of activities supervised by sessional play workers. The activities have included gardening and looking at different plants, this has also included decorating their own plant pots. The girls have taken part in themed and seasonal activities i.e. making Easter nests, Christmas decorations and mother's day gifts. There are 2 support workers who work with the children and we also have a number of parent volunteers who will stay and help the children when they need support.

There has been an increase in the girl's confidence and their social skills have improved over the first 6 months of attending. This has been shown by the growing membership and the amount of girls who now take part in the group without needing extra support.

Action for ASD Support Groups

The Action for ASD support group is held on the first Thursday of every month. This group is open to parents to come and talk to other parents who have gone through similar experiences. The group is also an ideal place for new members to meet more long standing members of the children's service.

Over the last 12 months we have run 10 support groups and overall 30 parents and carers have attended. The support group is also useful to consult with parents and carers about the services we provide.

The support group can also be accessed by professionals who attend to provide the parents with an overview of their services. This year the support group has been attended by speech and language therapists, nurses from the paediatric learning disability team, SENCO's and teaching assistants from local schools.

Action for ASD Training

'Getting the best out of a meeting' training was held at Action for ASD on Mon, 3rd Feb 2014 from 5.30-7.30. This training attended by 15 parents and carers during the family session and was funded by the Parent Participation Grant. Feedback from this event was very positive and we hope to run another training session in the future.

Lyndsey Birtwistle, who is a speech and language therapist from 'Bright Sparks', attended the family session on Monday 2nd December 2013. She delivered a presentation to parents about speech and language difficulties in children; this was attended by 6 members.

Evelyn Ashford visited the centre on Thursday 27th June 2013, to give the support group a brief presentation about the statementing process and her organisation Educational Equality. 6 parents attended the workshop and found it very useful.

Adult Services

Adult Project

2013/2014 has been the second year of the adult project and this year has seen the project grow from strength to strength. The Adult Project is funded by East Lancashire PCT and Blackburn with Darwen and is a follow on project from the Research Project which came to an end in 2011.

The project is focused on adults with Asperger Syndrome/High Functioning Autism aged 16 years and above who live in the East Lancashire area and Blackburn with Darwen. The Adult Project offers a range of support for adults from one to one low level support on daily living skills to adult social groups, social events and drop in sessions.

The Project in its second year has had contact with over 260 adults who have accessed the project in some way whether this be through telephone support, one to one meetings, social events, information and advice or signposting to relevant agencies. In September 2013 Action for ASD were successful with a proposal to East Lancashire NHS and Blackburn with Darwen in winning further funding to develop the Adult Project. This increase in funding enabled the project to employ one full time and two part time outreach workers in addition to the Adult Services Manager to work with adults in the community.

The increase in funding has also enabled Action for ASD to provide a new contract for a specialist counselling service to work with adults post diagnosis and counselling for adults previously diagnosed who have not found generic counselling successful and require a specialist counselling service.

As well as providing funding for the outreach work and counselling the 2nd year of funding has included funding for the Diagnosis and Screening Assessor who is employed by Action for ASD to provide screening for GP's which helps to indicate whether clients require further full assessment for their diagnosis.

Adult Social Groups/ Drop In

The Adult Social Group Drop In sessions for adults who have a diagnosis of Asperger Syndrome/High Functioning Autism are held every Tuesday evening from 6 - 8pm. Over the 2013/14 there have been 49 Tuesday night sessions with 131 people accessing the sessions.

Trustees' Report

This session provides a safe environment where people can learn social and communication skills without judgment but with support and guidance. The level of interaction which takes place during this session is entirely up to the individual as the room is divided into Zones. The outer part of the room is used by individuals who prefer to remain alone or watch without interruption. No one will approach them while they are in this zone. The seated area/sofas are usually occupied by individuals with support or who are prepared to communicate at a low level. The tables provide an opportunity for individuals to interact at a more increased level but who feel more comfortable doing this whilst focused on an activity of some sort. The centre of the room is usually used for the more confident and proactive members or for individuals who feel they are able to communicate more easily. Individuals can move through the different zones according to how they are feeling and whether or not they are able to communicate at that time. Activities during this session can include, table top football, pool, tabletop air hockey, painting, card making, board games, console games and card games.

Action for ASD also holds a Thursday afternoon Drop In session for people who cannot attend on Tuesday evening. These sessions proved so popular that they are also being held every week. There have been 44 different sessions and 59 people have attended these sessions over the year.

Often during holiday periods activities are arranged away from the ARC and can include, trips to stately homes, visiting the Queen Street Mill, canal boat trips, cinema trips, bowling, museum visits.

Pre Diagnosis Screening

In February 2013 East Lancashire PCT commissioned Action for ASD to provide the diagnostic pathway for adults with Asperger Syndrome as part of the adult service. This service provides the following; the preliminary stage of the diagnostic pathway where adults are supported to complete the AAA self-diagnostic tool which will help them determine whether they need to move on for a full diagnostic assessment. If the person reaches the criteria for referral for a further assessment they will then be provided with a diagnosis assessment by BTSS. Over the year there were 115 referrals for the screening process. Around the screening Action for ASD is also in a position to offer counselling sessions to help adults on the diagnostic pathway and to support them after diagnosis.

East Lancashire PCT Training

As part of the research programme the results of the Training Analysis for PCT staff in the East Lancashire area indicated their staff had little experience and training in Autism. This highlighted the need for basic awareness training in Autism for professionals working with this client group in mental health teams across East Lancashire.

We provided a training day at the ACE Centre in Nelson for East Lancashire PCT professionals. This training day was facilitated by Chris Barson from Positive about Autism. The feedback from these was excellent and we hope to be able to offer more training over the next year.

Consultation with Service Users

Young People's Panel

This panel meets on a regular basis to allow young members the voice to help steer the charity in its goals, achievements and future projects. It also helps the children and young people to develop their social skills and learn the skills of being in a committee and having roles within the group.

Trustees' Report

Parent Consultation Meetings

These meetings have been held twice over the year. The meetings are a forum for parents to come to the project and share their views and opinions on the service and the projects we offer. It helps us to shape services to meet the needs of the family and to ensure we are aware of what we are doing right, what we need to change and how we can improve all the services. This year Action for ASD decided to hold one consultation meeting in September 2013 and to get more parents' and carers' views a questionnaire was distributed in March 2014. The questionnaire was sent to all members of the charity to enable Action for ASD to gain a more in-depth analysis of members' views. This helped us to gain information from parents and carers of what they feel the charity is doing well, if there are any services or support that could be improved and how we can move forward and develop our services to meet the needs of their children and families.

Financial Review

Fundraising

Our respite funding for families in the form of the Lancashire County Council's (LCC) Lancashire Break Time (£93,211 received from LCC and parental contributions) was only allocated to us for portions of the year, which put a major strain on the provision of our Children's Services. In periods when this funding was unavailable, we had to reduce the length and number of our sessions, as well as charging higher fees. Our Children in Need project (income of £29,253) was therefore essential in keeping these services going throughout the year.

The extension of our role with adults with autism from the East Lancashire NHS Clinical Commissioning Group (CCG) is documented elsewhere in this report. The income from this project was £114,465.

The Three Guineas Trust, who have supported us for many years in the form of funding a vital administrative post, again provided us with income of £15,000, and Burnley Borough Council funded us with £1,000 at the end of the year to provide training for the parents of autistic children.

Donations of £1,652 were received, for which we are extremely grateful. Our particular thanks for donations given by Ellesmere Lodge, Line Mark, the Colne Darts League and the Nelson Ladies Darts Team.

We are also appreciative of two substantial fundraising efforts, namely Kirsty Lavin's sponsored swim (£338) and Leighton Cragg (£305).

Resources expended

2013/14 resources expended of £280,628 showed a decrease of £34,737 compared with the previous year, when expenditure had been £315,365. The reasons for this are as follows:

- During 2012/13 we acquired our second unit at the ARC. This enabled projects that had previously been put on hold to be completed and there had been a good deal of refurbishment (£20,832) and purchasing of equipment (£16,428). This work had been completed in 2012/13;
- Funding for (mainly children's) resources and activities was massively reduced from £29,324 to £2,664. This was due to the tight constraints to which our Children's services were subjected due to the lack of availability of funding for the full year.
- Conference costs reduced from £9,375 to £1,257, as the training programme for NHS staff was substantially completed in 2012/13.

These decreases are partially offset by staff costs being significantly higher (an increase of £28,475).

This is almost entirely due to the expansion of the Adult Project, as various new members of staff joined the Adult team throughout the year.

Trustees' Report

Balances on some smaller, longer standing funds such as the Co-operative Community Foundation Fund were also spent during 2013/2014, contributing to overall net outgoing resources of £17,585.

Reserves policy

At the close of the year the reserves of the charity were as follows:

- Unrestricted £32,849 (2012/13 £31,704)
- 2) Designated £44,412 (2012/13 £41,819)
- 3) Restricted £65,622 (2012/13 £86,945)

Major items of core expenditure are mainly funded by contributions in project grants. However the trustees recognise that an unrestricted reserve is required should this no longer be the case. The trustees' aim is for up to three months' expenditure to be held in reserve. Reserves held are within this parameter.

Designated funds are held in reserve for the continuation of our Adults' (£17,121) and Children's (£27,291) activities in the event of funding for these activities no longer being received. Net expenditure of £1,834 was spent from the Children's Reserve in 2013/14 on unfunded Children's services' staffing.

The major part of the 2013/14 balance relates to the ongoing Adult Project funded by the East Lancashire NHS CCG (£48,222).

Summary

Income for the year comprised grants totalling £257,482 (2012/13 £252,625) to fund specific projects and a further £5,561 (2012/13 £5,017) from smaller donations, membership fees and other fundraising activity.

Expenditure for the year totalled £280,628 (2012/13 £315,365). Net outgoing resources were £17,585 (2012/13 £57,723).

FUTURE PLANS FOR 2014/2015

Children's Activities

The main focus for Children's services is to secure funding from Lancashire Break Time for the full year. There is a review of all the LBT funding for 2014/2015 so we will be applying to Lancashire County Council and other funders to secure this funding for the next year. Securing funding for the full year enables the Children's Services Manager to develop and plan services over the year in terms of sessions planned and staffing.

When funding is secured it is intended that Children's Services will continue with the same activities and sessions that have taken place this year. These sessions will continue to provide support and activities during the week, weekends and holidays. Family sessions will still continue on a Monday evening but this will be dependent on funding as Children In Need funding ceases in December 2014.

The new Girls Group has been found to be very popular and we would like this to continue into the next year. We will try and secure funding for this as a separate project so we can grow this into a more regular session and hold them at the ARC on alternate weeks.

The Project Director will endeavour to secure funding for a Family Support Worker. Through evaluation and experience Action for ASD knows that parents and carers require increased support and advice pre and post diagnosis and we are increasingly being asked to provide more in-depth support. The Family Support Worker would also provide training to parents on ASD and related issues.

Training for parents is a further aim for this year. Burnley Council has provided part funding to provide a series of workshops and training days for parents and carers. The Project Director will source further funding

Trustees' Report

The Support Group for Parents will continue to meet once a month and the Children's Service Manager will ensure a variety of speakers and professionals will attend to enable the parents and carers to improve their knowledge and experience.

Adult Project

The Adult Services will continue to develop in 2014/2015 as East Lancashire NHS and Blackburn with Darwen NHS have funded a further year for the adult services to develop. The service will continue much the same as 2013/2014 but will build on the first year of the project.

New developments for the project will be;

A new Monday Life Skills Course. These workshops will provide a selection of activities over short periods of time to include – budgeting, cooking, shopping, food preparation, hygiene, dietary needs, communication skills, street safety, Getting into work - completing a CV, completing a job application, interview preparation, dressing appropriately.

On a Thursday morning Adult Services will run a College Drop In with Accrington & Rossendale College and/or Burnley College. It is hoped that service users will attend short basic skills course at the ARC as many find attending traditional colleges overwhelming and therefore do not access any higher or further education.

The Pre Diagnosis Screening and Diagnosis and Assessment Service will continue for 2014/2015. It is estimated a further 100 people will be referred to Action for ASD for Diagnostic Services over the year.

The Adult Services are also planning to arrange a short holiday in 2014 for adult service users. This is one of the requests that we have found through our service evaluations in Adult Services.

Training for Staff

As part of the training for staff this year we will be offering the following training for staff;

NAPPI (Non-physical intervention training), Food Hygiene, Child Protection and Safeguarding, Autism Awareness, Epilepsy, Challenging Behaviour and all legal Health and Safety Training.

There will be other training offered over the year as and when required but we intend all of our staff to have at least a minimum level of training.

NVQ

Action for ASD will continue to support members of staff through the NVQ process and we hope all senior managers will complete the NVQ Level 5 training in either adults' or children's social care.

We will endeavour to train all contracted staff in level 2 or 3 dependent on their responsibilities and job role.

Consultation with Service Users

Young Peoples Panel

This Panel will continue to meet once a month and it will be a forum for the young people to come together and give their views and opinions on the services we provide but also to help shape the future of children's services. This forum will also be an opportunity for young people to practise their social and communication skills and improve their confidence and self-esteem.

Parent Consultation Meetings

These meetings will be held twice a year to gather parents together to find out what works, what does not work and what improvements can be made. It also helps to give us views on what the parents need now and in the future and gives us the basis to form our development plans and how the project will grow to meet all the families' needs.

Trustees' Report

We will continue to use Facebook and other social networks to connect with families to impart information and to gather ideas and views from parents.

Family Events

Over the Christmas Period we will organise the Manchester Pantomime Trip and annual Christmas Celebrations.

Fundraising

The Project Director will continue to complete funding applications to a number of organisations and trusts to ensure the continued development of Action for ASD and to develop new projects in line with our Business Plan.

We will be applying for funding from Lancashire County Council from the Lancashire Break Time funding to continue to provide the children and young people's sessions through term time and in the school holidays.

The trustees (who are also directors of Action for ASD for the purposes of company law) are responsible for preparing the Trustees' Annual Report and the financial statements in accordance with applicable law and the United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charitable company will continue in business.

The trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the charitable company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

The charity's gross income exceeded £250,000 and I am qualified to undertake the examination by being a qualified member of the Association of Charity Independent Examiners.

Having satisfied myself that the charity is not subject to audit under company law and is eligible for independent examination, it is my responsibility to:

- examine the accounts under section 145 of the 2011 Act;
- follow the procedures laid down in the General Directions given by the Charity Commission under section 145(5)(b) of the 2011 Act; and

1 Accounting policies

Basis of preparation

The financial statements have been prepared under the historical cost convention and in accordance with the Statement of Recommended Practice 'Accounting and Reporting by Charities (SORP 2005)', issued in March 2005, the Financial Reporting Standard for Smaller Entities (effective April 2008) and the Companies Act 2006.

Fund accounting policy

Unrestricted income funds are general funds that are available for use at the trustees' discretion in furtherance of the objectives of the charity.

Restricted funds are those donated for use in a particular area or for specific purposes, the use of which is restricted to that area or purpose.

Designated funds are unrestricted funds set aside at the discretion of the trustees for specific purposes.

Further details of each fund are disclosed in note 18.

Incoming resources

Voluntary income including donations and grants that provide core funding or are of a general nature is recognised where there is entitlement, certainty of receipt and the amount can be measured with sufficient reliability.

Investment income is recognised on a receivable basis.

Resources expended

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to the expenditure. All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category.

Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

Governance costs

Governance costs include costs of the preparation and examination of the statutory accounts, the costs of trustee meetings and the cost of any legal advice to trustees on governance or constitutional matters.

Fixed assets

From 1 April 2011 all items of a capital nature are written off as equipment in the year of purchase.

Operating leases

Rentals payable under operating leases are charged in the statement of financial activities on a straight line basis over the lease term.
