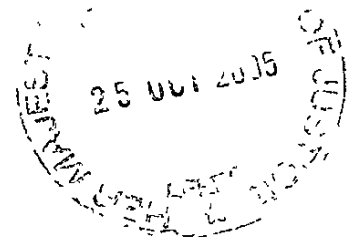

AND UPON reading the Witness Statements of the Applicants, the exhibit thereto and letters from the Respondents

BY CONSENT it is ordered that

- 1 Such of the insolvency proceedings set out in the attached schedule that are proceeding in any Court other than this Court be transferred to this Court for the purposes of this Application and thereafter be transferred back to that Court
- 2 The First Applicant be removed from his office as joint Administrator of the administrations set out in the schedule hereto
- 3 The First Applicant be removed from his office as joint supervisor of the company voluntary arrangements set out in the schedule hereto
- 4 The costs of this Application be an expense of the voluntary arrangements and administrations and be apportioned rateably, save to the extent that where funds are not available in any of these insolvencies costs will be attributed to those insolvencies where funds are available, for the purpose of discharging the costs of this application, provided that costs payable pursuant to this Order in relation to any insolvency shall not exceed 10% of the value of the received assets in that particular insolvency



- 5 There be liberty to each creditor of the estates listed in the schedule herein to apply to vary or discharge this Order in so far as it relates to an estate of which that person is a creditor within 28 days of being given notice of the same
- 6 Within 28 days of his appointment the relevant Respondent is to write to each creditor explaining the terms of this Order
- 7 Pursuant to rule 7 4(6) of the Insolvency Rules 1986 the need to serve this application upon the Respondents be dispensed with
