

- Pursuant to section 18(3) of the Insolvency Act 1986, the administration order made on 7 February 2003 be discharged on 12 August 2013
- Pursuant to section 20(1)(b) of the Insolvency Act 1986, the Applicant be released as administrator upon the expiry of 14 days following compliance with his obligations under the former Rule 2 52 of the Insolvency Rules 1986
- The Applicant do have liberty to apply to vary the undertakings given above and/or the date for discharge of the administration order specified in paragraph 2 above.
- The costs of and incidental to this application be paid as an expense of the administration of the Company
