**This Deed** is made on

13 September 2021

**Between**

- (1) The companies listed in Schedule 1 (*Chargors*) (the "**Chargors**"); and
- (2) **Situs Asset Management Limited** as security trustee for the Secured Parties (as defined in the Facilities Agreement (as defined below) (the "**Security Agent**").

**Background:**

- (A) Each Chargor enters into this Deed in connection with the Facilities Agreement (as defined below).
- (B) It is intended that this document takes effect as a deed notwithstanding the fact that a party may only execute this document under hand.

**It is agreed** as follows:

**1. Definitions and interpretation**

- 1.1 Unless otherwise defined in this Deed, a capitalised term used in this Deed has the meaning given to it in the Facilities Agreement. In this Deed:

**"Act"** means the Law of Property Act 1925.

**"Bank Accounts"** means, in relation to a Chargor, all its right, title and interest from time to time in and to all present and future bank accounts of the Chargors, including the bank accounts described in Part 1 of Schedule 2 (*Bank Accounts*), all current, deposit or other accounts with any bank or financial institution, all balances from time to time standing to the credit of or accrued or accruing on those accounts and all Related Rights.

**"Facilities Agreement"** means the facilities agreement dated 13 September 2021 between (among others) each Chargor and the Security Agent.

**"Intellectual Property"** means all interests in and to:

- (a) any patents, trade marks, service marks, designs, business names, copyrights, database rights, design rights, domain names, moral rights, inventions, confidential information, knowhow and other intellectual property rights and interests whether registered or unregistered;
- (b) the benefit of all applications and rights to use such assets; and
- (c) any related licences and sub-licences of the same.

**"Investments"** means all shares in any Obligor owned by each Chargor or held by any nominee or trustee on its behalf.

**"Licences"** means each and all of the grants, authorities, licences, quotes, certificates and justices and excise licences now or in the future attached to the Security Assets and/or the business of a Chargor.

**"Partner"** means:

- (a) Retirement Bridge Limited (company number: 05358018);
- (b) Equity Release Investment Properties Limited (company number: 05348579);
- (c) Milford Reversions Limited (company number: 05417664); and

(d) Economic Reversions Limited (company number: 05526876).

**"Partnership Agreement"** means each agreement constituting a limited partnership or a limited liability partnership in which a Chargor has an interest from time to time.

**"Partnership Interest"** means the rights, title and interests of any Chargor (whether as a limited partner, general partner or otherwise) in a limited partnership or a limited liability partnership or held by any nominee or trustee on its behalf including (but not limited to) all capital, profits, income, rights or benefits in respect of such interest pursuant to the terms of the relevant members' agreement and all Partnership Related Rights.

**"Partnership Related Rights"** means, in relation to each Partnership Agreement, all distributions of profits or capital or of whatsoever nature paid or payable after the date of this Deed in respect of any Partnership Agreement or all or any of the Partnership Interest and any rights, money or property accruing or offered at any time in any manner in respect of any Partnership Agreement and the Partnership Interests or in substitution or exchange for any Partnership Agreement or all or any of the Partnership Interest.

**"Party"** means a party to this Deed.

**"Receiver"** means a receiver or receiver and manager or administrative receiver, in each case appointed under this Deed.

**"Real Property"** means, in relation to a Chargor, all its right, title and interest from time to time in and to any freehold or leasehold property in England and Wales and other real or heritable property anywhere in the world, in each case, all rights and security attached or appurtenant or related thereto and all buildings and fixtures from time to time on that property, and all Related Rights.

**"Related Rights"** means, where used in relation to a Security Asset, the following:

- (a) any proceeds of sale, transfer or other disposal, lease, licence, sub-licence, or agreement for sale, transfer or other disposal, lease, licence or sub-licence, of that Security Asset;
- (b) any moneys or proceeds paid or payable deriving from that Security Asset;
- (c) any rights, claims, guarantees, indemnities, Security, authorisations, options, agreements, warranties or covenants for title in relation to that Security Asset;
- (d) any awards or judgments in favour of a Chargor in relation to that Security Asset; and
- (e) any other assets deriving from, or relating to, that Security Asset.

**"Relevant Contract"** means:

- (a) the Facility B Acquisition Agreement;
- (b) the Servicing Agreement;
- (c) other agreement relating to the acquisition of a Reversion;
- (d) each Partnership Agreement; and
- (e) the Licences;

in each case, including any guarantees or sureties entered into in respect of them.

**"Rental Income"** means the aggregate of all amounts paid or payable to or for the account of each Chargor in connection with the letting, licence or grant of other rights of use or occupation of any part of a Real Property, including each of the following amounts:

- (a) rent, licence fees and equivalent amounts paid or payable;
- (b) any sum received from any deposit held as security for performance of a tenant's obligations;
- (c) a sum equal to any apportionment of rent allowed in favour of any Obligor;
- (d) any other moneys paid or payable in respect of occupation and/or usage of that Property and any fixture and fitting on that Property including any fixture or fitting on that Property for display or advertisement, on licence or otherwise;
- (e) any sum paid or payable under any policy of insurance in respect of loss of rent or interest on rent;
- (f) any sum paid or payable, or the value of any consideration given, for the grant, surrender, amendment, supplement, waiver, extension or release of any Customer Contract;
- (g) any sum paid or payable in respect of a breach of covenant or dilapidations under any Customer Contract;
- (h) any sum paid or payable by or distribution received or receivable from any guarantor of any occupational tenant under any Customer Contract;
- (i) any tenant contributions; and
- (j) any interest paid or payable on, and any damages, compensation or settlement paid or payable in respect of, any sum referred to above less any related fees and expenses incurred (which have not been reimbursed by another person) by any Obligor.

**"Scottish Assets"** means all the assets and undertaking of each Chargor which are situated in Scotland or otherwise governed by Scots law.

**"Security Asset"** means any asset of each Chargor which is, or is expressed to be, subject to any Security created by this Deed.

**"Secured Liabilities"** means all present and future obligations and liabilities (whether actual or contingent and whether owed jointly or severally or in any other capacity whatsoever) of each Transaction Obligor to any Secured Party under each Transaction Document.

**"Security Period"** means the period beginning on the date of this Deed and ending on the date on which all the Secured Liabilities have been unconditionally and irrevocably paid and discharged in full.

**"Subordinated Debt"** has the meaning given to the term "Subordinated Debt" in the Deed of Subordination.

**"Title Documents"** means all deeds and documents relating to any Real Property;

## 1.2 **Construction**

- (a) The provisions of clause 1.2 (*Construction*) of the Facilities Agreement apply to this Deed as though they were set out in full in this Deed except that references to the Facilities Agreement will be construed as references to this Deed.
- (b) Unless a contrary indication appears, a reference in this Deed to:

- (i) a Transaction Document or any other agreement or instrument is a reference to that Transaction Document or other agreement or instrument as amended, novated, supplemented, extended or restated;
- (ii) any **"rights"** in respect of an asset includes:
  - (A) all amounts and proceeds paid or payable;
  - (B) all rights to make any demand or claim; and
  - (C) all powers, remedies, causes of action, security, guarantees and indemnities,

in each case in respect of or derived from that asset;

- (iii) any **"share"**, **"Partnership Interest"**, **"stock"**, **"debenture"**, **"bond"** or **"other security"** or **"investment"** includes:
  - (A) any dividend, interest or other distribution paid or payable;
  - (B) any right, money or property accruing or offered at any time by way of redemption, substitution, exchange, bonus or preference, under option rights or otherwise; and
  - (C) any other rights,

in each case in respect of that share, Partnership Interest, stock, debenture, bond or other security or investment; and

- (iv) the term **"this Security"** means any Security created by this Deed.
- (c) Any covenant of a Chargor under this Deed (other than a payment obligation which has been discharged) remains in force during the Security Period.
- (d) The terms of the other Transaction Documents and of any other agreement or instrument between any Parties in relation to any Transaction Document are incorporated in this Deed to the extent required to ensure that any purported disposition, or any agreement for the disposition, of any freehold or leasehold property contained in this Deed is a valid disposition in accordance with section 2(1) of the Law of Property (Miscellaneous Provisions) Act 1989.
- (e) If the Security Agent considers that an amount paid to it under a Transaction Document is capable of being avoided or otherwise set aside on the liquidation or administration of the payer or otherwise, then that amount will not be considered to have been irrevocably paid for the purposes of this Deed.
- (f) Unless the context otherwise requires, a reference to a Security Asset includes the proceeds of any disposal of that Security Asset.

### 1.3 **Third party rights**

- (a) Unless expressly provided to the contrary in a Transaction Document, a person who is not a Party has no right under the Third Parties Act to enforce or to enjoy the benefit of any term of this Deed.
- (b) Notwithstanding any term of any Transaction Document, the consent of any person who is not a Party is not required to rescind or vary this Deed at any time.
- (c) Any Receiver may enforce and enjoy the benefit of any clause which expressly confers rights on it, subject to paragraph (b) above and the provisions of the Third Parties Act.

## 2. **Creation of Security**

### 2.1 **General**

- (a) Each Chargor must pay or discharge the Secured Liabilities in the manner provided for in the Transaction Documents.
- (b) All the security created under this Deed:
  - (i) is created in favour of the Security Agent;
  - (ii) is created over present and future assets of each Chargor;
  - (iii) is security for the payment of all the Secured Liabilities; and
  - (iv) is made with full title guarantee in accordance with the Law of Property (Miscellaneous Provisions) Act 1994, or absolute warrandice in respect of Scottish Assets.
- (c) The Security Agent holds the benefit of this Deed and this Security on trust for the Secured Parties.

### 2.2 **Land**

- (a) Each Chargor charges by way of a first legal mortgage all estates or interests in any Real Property set out in Part 2 and Part 3 of Schedule 2 (*Real Property*).
- (b) To the extent that the same is not the subject of a mortgage under Clause 2.2(a) above, each Chargor assigns by way of security and agrees to assign by way of security to the Security Agent all of its right, estate, title, and interest (including the benefit of the legal title holder in the declaration of trust declared by Hodge Life Assurance Company Limited) in and to in any Real Property now or subsequently owned by it.
- (c) To the extent that the same are not effectively mortgaged under Clause 2.2(a) above or assigned under Clause 2.2(b) above, each Chargor charges by way of first fixed charge all estates or interests in any Real Property now or subsequently owned by it.
- (d) A reference in this Clause 2.2 to a mortgage, assignment, or charge of any Real Property includes:
  - (i) all buildings, fixtures, fittings and fixed plant and machinery on that property; and
  - (ii) the benefit of any covenants for title given or entered into by any predecessor in title of the Chargor in respect of that property or any moneys paid or payable in respect of those covenants.
- (e) Each Chargor shall promptly:
  - (i) notify the Security Agent of its acquisition of, or agreement to acquire, any Real Property in accordance with the terms of the Facilities Agreement or any heritable property or property located in Scotland subject to a long lease;
  - (ii) procure that all Title Documents in respect of any Real Property or any heritable property or property located in Scotland subject to a long lease are held to the order of the Security Agent;
  - (iii) in respect of the security created by Clause 2.2(a) over the Real Property listed in Part 2 of Schedule 2 (*Real Property*):

- (A) apply to the Land Registry to register the security; and
- (B) apply to the Land Registry requesting:
  - (i) a restriction in the form specified by the Security Agent; and
  - (ii) the obligation to make further advances to be entered on the register of the title to that Real Property.

### 2.3 **Future Real Property**

- (a) If any Chargor acquires (as sole legal and beneficial owner) any Real Property or any heritable property or property located in Scotland subject to a long lease after the date of this Deed, that Chargor shall as soon as reasonably practicable:
  - (i) apply to the Land Registry for first registration of that Real Property (where that Real Property is capable of being registered at the Land Registry and is not already so registered) and for registration of it as proprietor of that Real Property;
  - (ii) execute and deliver to the Security Agent a legal mortgage or standard security (as appropriate) of that Real Property, or any heritable property or property located in Scotland subject to a long lease, as security for the payment of all Secured Liabilities in a form and substance satisfactory to the security agent, acting reasonably;
  - (iii) if the title to that Real Property is registered at the Land Registry or required to be so registered, give the Land Registry written notice of the Security referred to in paragraph 2.3(b) or apply to the Registers of Scotland to register any standard security created pursuant to paragraph 2.3(b) above (as appropriate);
  - (iv) apply to the Land Registry requesting:
    - (A) a restriction in the form specified by the Security Agent; and
    - (B) the obligation to make further advances,
  - (v) to be entered on the register of the title to that Real Property in respect of any legal mortgage created pursuant to paragraph (b) above;
  - (vi) pay all applicable registration fees; and
  - (vii) deal with any requisitions by the Land Registry or Registers of Scotland relating to that Real Property or any heritable property or property located in Scotland subject to a long lease and keep the Security Agent informed as to the completion or rejection of any such application for registration,

or, if the Security Agent gives notice to that Chargor that the Security Agent will submit the relevant forms to the Land Registry or Registers of Scotland, that Chargor shall as soon as reasonably practicable provide the Security Agent with all duly completed forms reasonably requested by the Security Agent and all applicable registration fees.

- (b) For the purposes of this clause if any Real property is acquired in the Isle of Man the references to the Land Registry shall be construed as references to the Isle of Man Land Registry and also to the Isle of Man Companies Registry in relation to the registration of the legal mortgage

### 2.4 **Customer Contracts**

Each Chargor assigns absolutely, by way of security and agrees to assign by way of security (subject to the proviso for reassignment on redemption) to the Security Agent all of its rights:

- (a) under each Customer Contract;
- (b) in respect of all Rental Income; and
- (c) under any guarantee of Rental Income contained in or relating to any Customer Contract.
- (d) To the extent the same are not effectively assigned under paragraph (a) of this clause 2.3 (*Customer Contracts*), each relevant Chargor with full title guarantee charges to the Security Agent by way of first fixed charge such right, title, benefit or interest, as continuing security for the payment and discharge of the Secured Liabilities.

## 2.5 **Investments**

Each Chargor charges:

- (a) mortgages by way of a first legal mortgage the Investments, whether owned by it or held by any nominee or trustee on its behalf; and
- (b) (to the extent that they are not the subject of a mortgage under paragraph (a) above) by way of a first fixed charge its interest in all its Investments whether owned by it or held by any nominee or trustee on its behalf.

## 2.6 **Partnership Interests**

- (a) Each Chargor assigns absolutely by way of security and agrees to assign by way of security (subject to the proviso for reassignment on redemption) to the Security Agent:
  - (i) its Partnership Interests; and
  - (ii) all of its right, title and interest in and to:
    - (A) each Partnership Agreement; and
    - (B) the Partnership Related Rights,including all rights of enforcement of the same.
- (b) To the extent the same are not effectively assigned under paragraph (a) of this Clause 2.6 (*Partnership Interests*), each relevant Chargor with full title guarantee charges to the Security Agent by way of first fixed charge such right, title, benefit or interest, as a continuing security for the payment and discharge of the Secured Liabilities.
- (c) To the extent that any right, title or interest described in paragraph (a) above is not chargeable, assignable or capable of assignment or being charged either by reason of law or otherwise (or if the right, title or interest is deferred), the charge or assignment purported to be effected by paragraphs (a) or (b) above shall only operate as a charge or an assignment of any and all proceeds, damages, compensation, remuneration, profit, rent or income which the relevant Chargor may derive from such right, title or interest or be awarded or entitled to in respect thereof, in each case as continuing security for the payment, discharge and performance of its Secured Liabilities.
- (d) Each Chargor which is a member of Retirement Bridge Home Reversions LP hereby consents to the security granted over each of its members and Retirement Bridge Home Reversions LP under this Deed, (including in accordance with Clause 11 (*Undertakings*) of the Deed of Limited Partnership in respect of Retirement Bridge Home Reversions LP dated 22 May 2006 entered into between Retirement Bridge Limited (previously

Grainger Equity Release Management Limited) and Equity Release Investment Properties Limited (previously Grainger Equity Release Investment Properties Ltd) and waives any further actions that may be required to permit and legally assign or charge (as applicable) the security granted under this Deed.

- (e) Each Chargor which is a member of Elm Property Investments LLP hereby consents to the security granted over each of its members and Elm Property Investments LLP (including in accordance with Clause 16 (*Limitations*) and Clause 31 (*Assignment*) of the Elm Property Investments LLP Members' Agreement dated 14 June 2007 entered into between Elm Property Investments LLP and Milford Reversions Limited and Economic Reversions Limited) and waives any further actions that may be required to permit and legally assign or charge (as applicable) the security granted under this Deed.

#### 2.7 ***Plant and machinery***

Each Chargor charges by way of a first fixed charge all plant and machinery owned by each Chargor and its interest in any plant or machinery in its possession.

#### 2.8 ***Credit balances***

Each Chargor charges by way of a first fixed charge all of its rights in respect of its Bank Accounts, any amount standing to the credit of any of its bank accounts and the debt represented by it.

#### 2.9 ***Accounts and book debts etc.***

Each Chargor charges by way of a first fixed charge:

- (a) all of its book and other debts (including, without limitation, Subordinated Debt owed to it);
- (b) all other moneys due and owing to it; and
- (c) the benefit of all rights in relation to any item under paragraphs (a) and (b) above.

#### 2.10 ***Insurances***

- (a) Each Chargor assigns absolutely, subject to a proviso for re-assignment on redemption, all of its rights under any contract or policy of insurance taken out by it or on its behalf or in which it has an interest (together, the **Insurance Rights**).
- (b) To the extent that they have not been effectively assigned under paragraph (a) above, each Chargor charges by way of a first fixed charge all of its Insurance Rights.

#### 2.11 ***Intellectual Property***

Each Chargor charges by way of first fixed charge its interest in all its Intellectual Property.

#### 2.12 ***Other contracts***

- (a) Each Chargor:
  - (i) assigns, absolutely, subject to a proviso for re-assignment on redemption, all of its rights:
    - (A) under each Relevant Contract; and
    - (B) under any document, agreement or instrument to which it and any nominee or trustee is a party in respect of an Investment; and

- (ii) charges by way of a first fixed charge all of its rights under any other document, agreement or instrument to which it is a party, which has been given in its favour or of which it has the benefit except to the extent that it is subject to any fixed security created under any other term of this clause 2.
- (b) To the extent that they have not been effectively assigned under paragraph (a)(i) above, each Chargor charges by way of a first fixed charge all of its rights listed under paragraph (a)(i) above.

### 2.13 **Miscellaneous**

Each Chargor charges by way of first fixed charge:

- (a) its goodwill;
- (b) the benefit of any authorisation (statutory or otherwise) held in connection with its use of any Security Asset;
- (c) the right to recover and receive compensation which may be payable to it in respect of any Authorisation referred to in paragraph (b) above;
- (d) its uncalled capital; and
- (e) the benefit of all rights in relation to any item under paragraphs (a) to (d) above.

### 2.14 **Floating charge**

- (a) Each Chargor charges by way of a first floating charge (i) all its assets not otherwise effectively mortgaged, charged or assigned by way of fixed mortgage, fixed charge or assignment under this clause 2, and (ii) all its Scottish Assets whether or not effectively mortgaged, charged or assigned by way of fixed mortgage, fixed charge or assignment under this clause 2.
- (b) Except as provided below, the Security Agent may by notice to each Chargor convert the floating charge created by this clause 2.14 (*Floating charge*) into a fixed charge as regards any of each Chargor's assets specified in that notice if:
  - (i) an Event of Default is continuing; or
  - (ii) the Security Agent considers those assets to be in danger of being seized or sold under any form of distress, attachment, execution or other legal process or to be otherwise in jeopardy.
- (c) Subject to paragraph (d) below, the floating charge created by this clause 2.14 (*Floating charge*) may not be converted into a fixed charge solely by reason of:
  - (i) the obtaining of a moratorium; or
  - (ii) anything done with a view to obtaining a moratorium,under Part A1 of the Insolvency Act 1986.
- (d) Paragraph (c) above does not apply in respect of any floating charge referred to in subsection (4) of section A52 of Part A1 of the Insolvency Act 1986.
- (e) The floating charge created by this clause 2.14 (*Floating charge*) will (in addition to the circumstances when this may occur under the general law) automatically convert into a fixed charge over all of a Chargor's assets if:

- (i) an administrator is appointed or the Security Agent receives notice of an intention to appoint an administrator in respect of that Chargor;
  - (ii) that Chargor takes any step to create any Security in breach of clause 3.1 (*Security*) over any Security Asset subject to a floating charge; or
  - (iii) any person takes any step to effect any expropriation, attachment, sequestration, distress or execution against any such Security Asset.
- (f) The floating charge created by this clause 2.14 (*Floating charge*) is a "**qualifying floating charge**" for the purpose of paragraph 14 of Schedule B1 to the Insolvency Act 1986.
- (g) The provisions of clauses 2.14(b) and 2.14(e) will not apply to any Scottish Assets if, and to the extent that, a Receiver would not be capable of exercising his or her powers in Scotland pursuant to section 72 of the Insolvency Act 1086 by reason of such conversion by notice or automatic conversion.

### 3. **Restrictions on Dealings**

#### 3.1 **Security**

Except as expressly allowed under the Facilities Agreement or this Deed, no Chargor may create or permit to subsist any Security on any Security Asset.

#### 3.2 **Disposals**

Except as expressly allowed under the Facilities Agreement or this Deed, no Chargor may enter into a single transaction or a series of transactions (whether related or not and whether voluntary or involuntary) to dispose of all or any part of any Security Asset.

### 4. **Investments**

#### 4.1 **Deposit**

Each Chargor must immediately:

- (a) deposit with the Security Agent, or as the Security Agent may direct, all certificates and other documents of title or evidence of ownership in relation to its Investments; and
- (b) execute and deliver to the Security Agent all share transfers and other documents which may be requested by the Security Agent in order to enable the Security Agent or its nominees to be registered as the owner of or otherwise obtain a legal title to its Investments.

#### 4.2 **Calls**

- (a) Each Chargor must pay all calls or other payments due and payable in respect of any of its Investments in accordance with the Facilities Agreement.
- (b) If each Chargor fails to do so, the Security Agent may pay the calls or other payments in respect of any of its Investments on behalf of each Chargor. Each Chargor must immediately on request reimburse the Security Agent for any payment made by the Security Agent under this clause 4.2 (*Calls*).

#### 4.3 **Book debts and receipts**

- (a) Each Chargor must get in and realise its:

- (i) Rental Income and other amounts due from tenants or any other occupiers of its Funded Properties; and
- (ii) book and other debts and other moneys due and owing to it,

in the ordinary course of its business and hold the proceeds of the getting in and realisation in a Bank Account and on trust for the Security Agent until such amount is paid out of the Bank Account in accordance with the terms of the Transaction Documents.

#### 4.4 **Other obligations in respect of Investments**

- (a) Each Chargor must promptly send a copy to the Security Agent of, and comply with all requests for, information which is within its knowledge and which are made under any law or regulation or any similar provision contained in any articles of association, partnership agreement, trust instrument or other constitutional document, or by any listing or other authority, relating to any of its Investments. If it fails to do so, the Security Agent may elect to provide such information as it may have on behalf of each Chargor.
- (b) Each Chargor must comply with all other conditions and obligations assumed by it in respect of any of its Investments.
- (c) The Security Agent is not obliged to:
  - (i) perform any obligation of each Chargor;
  - (ii) make any payment;
  - (iii) make any enquiry as to the nature or sufficiency of any payment received by it or each Chargor; or
  - (iv) present or file any claim or take any other action to collect or enforce the payment of any amount to which it may be entitled under this Deed,

in respect of any of its Investments.

#### 4.5 **Voting rights**

- (a) Before this Security becomes enforceable:
  - (i) the voting rights, powers and other rights in respect of its Investments will be exercised:
    - (A) by each Chargor; or
    - (B) if exercisable by the Security Agent, in any manner which each Chargor may direct the Security Agent in writing; and
  - (ii) all dividends, distributions or other income paid or payable in relation to any Investments in accordance with the Facility Agreement must be paid into a Bank Account and may be paid out of the Bank Account in accordance with the terms of the Transaction Documents.
- (b) Each Chargor must indemnify the Security Agent against any loss or liability incurred by the Security Agent as a consequence of the Security Agent acting in respect of any of its Investments as permitted by this Deed on the direction of each Chargor.
- (c) After this Security has become enforceable, the Security Agent may exercise (in the name of each Chargor and without any further consent or authority on the part of each Chargor) any voting rights and any powers or rights which may be exercised by the

legal or beneficial owner of any Investment, any person who is the holder of any Investment or otherwise.

## 5. **Accounts**

### 5.1 **General**

In this clause 5 "**Account Bank**" means a person with whom a Chargor maintains a Bank Account.

### 5.2 **Notices of charge**

Each Chargor must, promptly following the date of this Deed, or if later promptly following the opening of a Bank Account:

- (a) serve a notice of charge, substantially in the form of Part 1 of Schedule 3 (*Forms of Letter for Account Bank*), on each Account Bank; and
- (b) use reasonable endeavours to ensure that each Account Bank acknowledges the notice, substantially in the form of Part 2 of Schedule 3 (*Forms of Letter for Account Bank*).

## 6. **Insurances**

Each Chargor must promptly (and in any event within three Business Days) following the date of this Deed, or if later promptly following the acquisition, creation or existence of an Insurance:

- (a) serve a notice of assignment, substantially in the form of Part 1 of Schedule 4 (*Forms of Letter for Insurers*), on each counterparty to an Insurance; and
- (b) use reasonable endeavours to ensure that such counterparty acknowledges that notice, substantially in the form of Part 2 of Schedule 4 (*Forms of Letter for Insurers*).

## 7. **Other contracts**

- (a) If the Security Agent so requests while an Event of Default is continuing, each Chargor must:
  - (i) serve a notice of assignment, substantially in the form of Part 1 of Schedule 5 (*Forms of Letter for Other Contracts*), on each counterparty to a Relevant Contract (other than a Partnership Agreement or the Servicing Agreement); and
  - (ii) use reasonable endeavours to ensure that such counterparty acknowledges that notice, substantially in the form of Part 2 of Schedule 5 (*Forms of Letter for Other Contracts*).
- (b) Each Partner, acknowledges that this Deed constitutes notice to it of the assignment and fixed charge given by each Partner in favour of the Security Agent pursuant to Clause 2.6 (*Partnership interests*) of this Deed.

## 8. **When Security Becomes Enforceable**

### 8.1 **Event of Default**

This Security will be immediately enforceable while an Event of Default is continuing.

### 8.2 **Discretion**

After this Security has become enforceable, the Security Agent may enforce all or any part of this Security in any manner it sees fit or as instructed in accordance with the Facilities Agreement.

### 8.3 **Statutory powers**

The power of sale and other powers conferred by section 101 of the Act, as amended by this Deed, will be immediately exercisable at any time after this Security has become enforceable.

## 9. **Enforcement of Security**

### 9.1 **General**

- (a) For the purposes of all powers implied by statute, the Secured Liabilities are deemed to have become due and payable on the date of this Deed.
- (b) Section 103 of the Act (restricting the power of sale) and section 93 of the Act (restricting the right of consolidation) do not apply to this Security.
- (c) The statutory powers of leasing conferred on the Security Agent are extended so as to authorise the Security Agent to lease, make agreements for leases, accept surrenders of leases and grant options as the Security Agent may think fit and without the need to comply with any provision of section 99 or section 100 of the Act.

### 9.2 **No liability as mortgagee in possession or creditor in possession**

Neither the Security Agent nor any Receiver will be liable, by reason of entering into possession of a Security Asset, to account as mortgagee in possession or creditor in possession or for any loss on realisation or for any default or omission for which a mortgagee in possession or creditor in possession might be liable.

### 9.3 **Privileges**

The Security Agent and each Receiver is entitled to all the rights, powers, privileges and immunities conferred by the Act on mortgagees and receivers duly appointed under the Act, except that section 103 of the Act does not apply.

### 9.4 **Protection of third parties**

No person (including a purchaser) dealing with the Security Agent or a Receiver or its or his/her agents will be concerned to enquire:

- (a) whether the Secured Liabilities have become payable;
- (b) whether any power which the Security Agent or a Receiver is purporting to exercise has become exercisable or is being properly exercised;
- (c) whether any money remains due under the Transaction Documents; or
- (d) how any money paid to the Security Agent or to that Receiver is to be applied.

### 9.5 **Redemption of prior mortgages**

- (a) At any time after this Security has become enforceable, the Security Agent may:
  - (i) redeem any prior Security against any Security Asset; and/or
  - (ii) procure the transfer of that Security to itself; and/or

- (iii) settle and pass the accounts of the prior mortgagee, chargee or encumbrancer; any accounts so settled and passed will be, in the absence of manifest error, conclusive and binding on each Chargor.
- (b) Each Chargor must pay to the Security Agent, immediately on demand, the costs and expenses incurred by the Security Agent in connection with any such redemption and/or transfer, including the payment of any principal or interest.

## 9.6 **Contingencies**

If this Security is enforced at a time when no amount is due under the Transaction Documents but at a time when amounts may or will become due, the Security Agent (or a Receiver) may pay the proceeds of any recoveries effected by it into a suspense account or other account selected by it.

## 9.7 **Financial collateral**

- (a) To the extent that the Security Assets constitute "financial collateral" and this Deed and the obligations of each Chargor under this Deed constitute a "security financial collateral arrangement" (in each case, for the purpose of and as defined in the Financial Collateral Arrangements (No. 2) Regulations 2003), the Security Agent will have the right after this Security has become enforceable to appropriate all or any part of that financial collateral in or towards the satisfaction of the Secured Liabilities.
- (b) Where any financial collateral is appropriated:
  - (i) if it is listed or traded on a recognised exchange, its value will be taken as being the value at which it could have been sold on the exchange on the date of appropriation; or
  - (ii) in any other case, its value will be such amount as the Security Agent reasonably determines having taken into account advice obtained by it from an independent commercial property adviser, investment bank or accountancy firm of national standing selected by it,

and each Finance Party will give credit for the proportion of the value of the financial collateral appropriated to its use.

## 10. **Receiver**

### 10.1 **Appointment of Receiver**

- (a) Except as provided below, the Security Agent may appoint any one or more persons to be a Receiver of all or any part of the Security Assets if:
  - (i) this Security has become enforceable; or
  - (ii) each Chargor so requests to the Security Agent at any time.
- (b) Any appointment under paragraph (a) above may be by deed, under seal or in writing under its hand.
- (c) Except as provided below, any restriction imposed by law on the right of a mortgagee to appoint a Receiver (including under section 109(1) of the Act) does not apply to this Deed.
- (d) The Security Agent is not entitled to appoint a Receiver solely as a result of the obtaining of a moratorium (or anything done with a view to obtaining a moratorium) under Part A1 of the Insolvency Act 1986 other than in respect of a floating charge referred to in subsection (4) of section A52 of Part A1 of the Insolvency Act 1986.

- (e) The Security Agent may not appoint an administrative receiver (as defined in section 29(2) of the Insolvency Act 1986) over the Security Assets if the Security Agent is prohibited from so doing by section 72A of the Insolvency Act 1986 and no exception to the prohibition on appointing an administrative receiver applies.

## 10.2 **Removal**

The Security Agent may by writing under its hand (subject to any requirement for an order of the court in the case of an administrative receiver) remove any Receiver appointed by it and may, whenever it thinks fit, appoint a new Receiver in the place of any Receiver whose appointment may for any reason have terminated.

## 10.3 **Remuneration**

The Security Agent may fix the remuneration of any Receiver appointed by it and the maximum rate specified in section 109(6) of the Act will not apply.

## 10.4 **Agent of each Chargor**

- (a) A Receiver will be deemed to be the agent of each Chargor for all purposes and accordingly will be deemed to be in the same position as a Receiver duly appointed by a mortgagee under the Act. Each Chargor alone is responsible for any contracts, engagements, acts, omissions, defaults and losses of a Receiver and for any liabilities incurred by a Receiver.
- (b) No Secured Party will incur any liability (either to each Chargor or to any other person) by reason of the appointment of a Receiver or for any other reason.

## 10.5 **Relationship with Security Agent**

To the fullest extent allowed by law, any right, power or discretion conferred by this Deed (either expressly or impliedly) or by law on a Receiver may after this Security becomes enforceable be exercised by the Security Agent in relation to any Security Asset without first appointing a Receiver and notwithstanding the appointment of a Receiver.

## 11. **Powers of Receiver**

### 11.1 **General**

- (a) A Receiver has all of the rights, powers and discretions set out below in this clause 11 in addition to those conferred on it by any law. This includes:
  - (i) in the case of an administrative receiver, all the rights, powers and discretions conferred on an administrative receiver under the Insolvency Act 1986; and
  - (ii) otherwise, all the rights, powers and discretions conferred on a receiver (or a receiver and manager and Scottish receiver) under the Act and the Insolvency Act 1986.
- (b) If there is more than one Receiver holding office at the same time, each Receiver may (unless the document appointing him/her states otherwise) exercise all of the powers conferred on a Receiver under this Deed individually and to the exclusion of any other Receiver.

### 11.2 **Possession**

A Receiver may take immediate possession of, get in and realise any Security Asset.

### 11.3 **Carry on business**

A Receiver may carry on any business of each Chargor in any manner he/she thinks fit.

#### 11.4 **Employees**

(a) A Receiver may appoint and discharge managers, officers, agents, accountants, servants, workmen and others for the purposes of this Deed upon such terms as to remuneration or otherwise as he/she thinks fit.

(b) A Receiver may discharge any person appointed by each Chargor.

#### 11.5 **Borrow money**

A Receiver may raise and borrow money either unsecured or on the security of any Security Asset either in priority to this Security or otherwise and generally on any terms and for whatever purpose which he/she thinks fit.

#### 11.6 **Sale of assets**

(a) A Receiver may sell, exchange, convert into money and realise any Security Asset by public auction or private contract and generally in any manner and on any terms which he/she thinks fit.

(b) The consideration for any such transaction may consist of cash or non-cash consideration and any such consideration may be payable in a lump sum or by instalments spread over any period which he/she thinks fit.

#### 11.7 **Compromise**

A Receiver may settle, adjust, refer to arbitration, compromise and arrange any claim, account, dispute, question or demand with or by any person who is or claims to be a creditor of each Chargor or relating in any way to any Security Asset.

#### 11.8 **Legal actions**

A Receiver may bring, prosecute, enforce, defend and abandon any action, suit or proceedings in relation to any Security Asset which he/she thinks fit.

#### 11.9 **Receipts**

A Receiver may give a valid receipt for any moneys and execute any assurance or thing which may be proper or desirable for realising any Security Asset.

#### 11.10 **Subsidiaries**

A Receiver may form a Subsidiary of each Chargor and transfer to that Subsidiary any Security Asset.

#### 11.11 **Delegation**

A Receiver may delegate his/her powers in accordance with this Deed.

#### 11.12 **Lending**

A Receiver may lend money or advance credit to any person.

#### 11.13 **Protection of assets**

A Receiver may:

- (a) effect any repair or insurance and do any other act which each Chargor might do in the ordinary conduct of its business to protect or improve any Security Asset;
- (b) commence and/or complete any building operation; and
- (c) apply for and maintain any planning permission, building regulation approval or any other Authorisation,

in each case as he/she thinks fit.

#### 11.14 **Other powers**

A Receiver may:

- (a) do all other acts and things which he/she may consider necessary or desirable for realising any Security Asset or incidental or conducive to any of the rights, powers or discretions conferred on a Receiver under or by virtue of this Deed or law;
- (b) exercise in relation to any Security Asset all the powers, authorities and things which he/she would be capable of exercising if he/she were the absolute beneficial owner of that Security Asset; and
- (c) use the name of each Chargor for any of the above purposes.

#### 12. **Application of Proceeds**

All amounts from time to time received or recovered by the Security Agent or any Receiver pursuant to the terms of this Deed or in connection with the realisation or enforcement of all or part of this Security will be held by the Security Agent and applied in accordance with the Facilities Agreement. This clause 12:

- (a) is subject to the payment of any claims having priority over this Security; and
- (b) does not prejudice the right of any Secured Party to recover any shortfall from each Chargor.

#### 13. **Delegation**

##### 13.1 **Power of Attorney**

The Security Agent or any Receiver may, at any time, delegate by power of attorney or otherwise to any person for any period all or any right, power, authority or discretion exercisable by it under this Deed.

##### 13.2 **Terms**

Any such delegation may be made upon any terms and conditions (including the power to sub-delegate) and subject to any restrictions that the Security Agent or that Receiver (as the case may be) may, in its discretion, think fit in the interests of the Secured Parties.

##### 13.3 **Liability**

Neither the Security Agent nor any Receiver shall be bound to supervise, or be in any way responsible for any damages, costs or losses incurred by reason of any misconduct, omission or default on the part of, any such delegate or sub-delegate.

#### 14. **Further Assurances**

14.1 Each Chargor must promptly, at its own expense, take whatever action the Security Agent or a Receiver may reasonably require for:

- (a) creating, perfecting or protecting any security over any Security Asset intended to be created by this Deed; or
- (b) facilitating the realisation of any Security Asset, or the exercise of any right, power or discretion exercisable, by the Security Agent or any Receiver or any of their respective delegates or sub-delegates in respect of any Security Asset.

14.2 The action that may be required under paragraph 14.1(a) above includes:

- (a) the execution of any charge, transfer, conveyance, assignment, disposition, conveyance, standard security or assurance of any assets forming part of the Secured Assets, whether to the Security Agent or to its nominees; or
- (b) the giving of any notice, order or direction and the making of any filing or registration,

which, in any such case, the Security Agent may consider necessary but does not include the execution of any mortgage or charge over any real property owned by a Chargor nor the registration of any Security with H.M. Land Registry.

#### 15. **Power of Attorney**

Each Chargor, by way of security, irrevocably and severally appoints the Security Agent, each Receiver and any of their respective delegates or sub-delegates to be its attorney with the full power and authority of each Chargor to execute, deliver and perfect all deeds, instruments and other documents in its name and otherwise on its behalf and to do or cause to be done all acts and things, in each case which may be required or which any attorney may in its absolute discretion deem necessary for carrying out any obligation of that Chargor under or pursuant to any Transaction Document and which that Chargor has failed to do or generally for enabling the Security Agent or any Receiver to exercise the respective powers conferred on them under any Transaction Document or by law. Each Chargor ratifies and confirms whatever any attorney does or purports to do under its appointment under this clause 15.

#### 16. **Miscellaneous**

##### 16.1 ***Continuing Security***

This Security is a continuing security and will extend to the ultimate balance of the Secured Liabilities regardless of any intermediate payment or discharge in whole or in part.

##### 16.2 ***Tacking***

The Lender must perform its obligations under the Facilities Agreement (including any obligation to make available further advances).

##### 16.3 ***New Accounts***

- (a) If any subsequent charge or other interest affects any Security Asset, a Secured Party may open a new account with each Chargor.
- (b) If that Secured Party does not open a new account, it will nevertheless be treated as if it had done so at the time when it received or was deemed to have received notice of that charge or other interest.

- (c) As from that time all payments made to that Secured Party will be credited or be treated as having been credited to the new account and will not operate to reduce any Secured Liability.

#### 16.4 ***Time deposits***

Without prejudice to any right of set-off any Secured Party may have under any other Transaction Document or otherwise, if any time deposit matures on any account each Chargor has with any Secured Party within the Security Period when:

- (a) this Security has become enforceable; and
- (b) no Secured Liability is due and payable,

that time deposit will automatically be renewed for any further maturity which that Secured Party considers appropriate.

#### 16.5 ***Notice to Chargor***

This Deed constitutes notice in writing to each Chargor of any charge or assignment of a debt owed by each Chargor to any Transaction Obligor and contained in any other Security Document.

#### 16.6 ***Security Agent Provisions***

- (a) The Security Agent executes this Deed as security agent in the exercise of the powers and authority conferred and vested in it under the Facilities Agreement and any other Transaction Document for and on behalf of the Secured Parties for whom it acts. It will exercise its powers, rights, duties and authority under this Deed in the manner provided for in the Facilities Agreement and, in so acting, the Security Agent shall have the protections, immunities, rights, powers, authorisations, limitations of liability, indemnities and benefits conferred on it under and by the Facilities Agreement and the other Transaction Documents.
- (b) The Security Agent shall not owe any fiduciary duties to any party to this Deed or any of their directors, employees, agents or affiliates.
- (c) Notwithstanding any other provisions of this Deed, in acting under and in accordance with this Deed the Security Agent is entitled to seek instructions from the Secured Parties in accordance with the provisions of the Facilities Agreement and at any time, and where it so acts or refrains from acting on the instructions of a Secured Party or Secured Parties entitled to give it instructions, the Security Agent shall not incur any liability to any person for so acting or refraining from acting.

#### 16.7 ***The Finance Parties***

- (a) Any Finance Party may assign or otherwise dispose of all or any of its rights under this Deed in accordance with the Transaction Documents to which it is a party.
- (b) References to the Security Agent in this Deed include any successor Security Agent appointed under the Facilities Agreement.

#### 17. ***Release***

At the end of the Security Period, the Finance Parties must, at the request and cost of each Chargor, take whatever action is necessary to release its Security Assets from this Security.

18. **Governing Law**

This Deed and any non-contractual obligations arising out of or in connection with it are governed by English law.

**This Deed** has been executed and delivered as a deed on the date stated at the beginning of this Deed.
