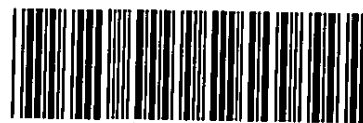

The Directors are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Company and to enable them to ensure that the accounts comply with Section 393 (1) of the Act. They are also responsible for safeguarding the assets of the Company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

1 ULTIMATE PARENT COMPANY

The Company's immediate parent company and controlling undertaking is Acappella Group Holdings Limited (formerly known as Thdreel Limited)

Up to 10 February 2014 the Company's immediate parent company and controlling undertaking was Willis Group Services Limited. On 11 February 2014 Thdreel Limited became the Company's immediate parent and controlling undertaking following the transfer of ownership in the Company from Willis Group Services Limited to Thdreel Limited. On 12 February 2014 Thdreel Limited changed its name to Acappella Group Holdings Limited.

The Company's ultimate parent company and controlling party is Willis Group Holdings plc, a company incorporated in Ireland, whose group financial statements are available from the Company Secretariat, 51 Lime Street, London EC3M 7DQ.

The results of the Company are only consolidated by Willis Group Holdings plc.

2 ACCOUNTING POLICIES

The Balance Sheet has been prepared under the historic cost convention and in accordance with the requirements of Section 396 (1) (a) and (2) (a) of the Act and accounting standards applicable in the United Kingdom.

3 PROFIT AND LOSS ACCOUNT
