DIRECTORS' REPORT

The directors present their annual report and the audited accounts of the company for the year ended 31 May 2012

BUSINESS REVIEW AND PRINCIPAL ACTIVITY

The company is a wholly owned subsidiary of Deloitte LLP and operates as part of the group's audit division

The principal activity is the provision of audit related services to member firms of the Deloitte Touche Tohmatsu organisation

As shown in the company's profit and loss account on page 6, the company's revenues increased by 25% over the prior year

The balance sheet on page 7 of the financial statements shows that the company's financial position, in net asset terms, is £2 (2011 £nil)

Overall, the directors consider the performance of the company to be in line with expectations

Deloitte LLP manages its operations on a divisional basis. For this reason the company's directors believe that further key performance indicators for the company are not necessary or appropriate for an understanding of the development, performance or position of the company. The performance of the audit division which includes this company, is discussed in the group's Annual Report for the year ended 31 May 2012 which does not form part of this report.

PRINCIPAL RISKS AND UNCERTAINTIES

The company is exposed to the movement in the US Dollar exchange rates on any revenue and costs generated. The company does not hedge or enter into forward or derivative transactions and is exposed to translation and transaction foreign currency exchange risk.

The company has no third party debt and therefore no interest rate exposure

Group risks are discussed in the group's Annual Report for the year ended 31 May 2012, which does not form part of this report

RESULTS AND DIVIDENDS

Turnover for the year was £795,000 (2011 £634,000) The profit for the year before taxation was £3,000 (2011 £nil)

The directors do not recommend the payment of a dividend for the year (2011 £nil)

All directors, except R W Warburton, were remunerated as members of Deloitte LLP and received no remuneration, from any source, for services as directors of the company during the current or preceding year

R W Warburton was remunerated by Deloitte Limited for his services as a director of a number of entities owned, either directly or indirectly, by Deloitte LLP. It is not practicable to allocate his remuneration between that earned between the entities in which he served as a director. Therefore Deloitte Limited did not make any charge to other group companies in respect of his directorship or his services provided during the current or preceding financial year.

ENVIRONMENT

The Deloitte LLP group recognises the importance of its environmental responsibilities, monitors its impact on the environment, and designs and implements policies to reduce any damage that might be caused by the group's activities. The company operates in accordance with group policies, which are described in the group's Annual Report for the year ended 31 May 2012 which does not form part of this report. Initiatives designed to minimise the group's impact on the environment include recycling, waste management, energy procurement and consumption and greening the supply chain.

Foreign currency

Transactions undertaken in foreign currencies are translated into Pounds Sterling at the rate of exchange ruling at the date of the transaction. Balances outstanding at the period end are translated into Pounds Sterling at the exchange rate ruling at the balance sheet date. All translation differences are recorded in the profit and loss account.

Current taxation

Current tax, including UK corporation tax and foreign tax, is provided at amounts expected to be paid (or recovered) using the tax rates and laws that have been enacted or substantively enacted by the balance sheet date
