3. Business Review and future prospects

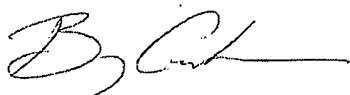

- prepare the financial statements on a going concern basis unless it is inappropriate to presume that the Company will continue in business.

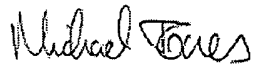

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2021

1. General information

Highway Corporate Capital Limited (the 'Company') is registered as a Corporate Name at Lloyd's, but is now dormant. The Company is limited by shares, domiciled and incorporated in United Kingdom.

2. Accounting policies

BASIS OF PRESENTATION

These financial statements have been prepared in accordance with UK-adopted International Accounting Standards ('IFRS').

As the Company has discontinued its primary operations the financial statements have not been prepared on a going concern basis. However, at 31 December 2021, all remaining assets are either fully recoverable or supported by the ultimate parent company and therefore there has been no impact of this change on the valuation of the Company's statement of financial position. Consequently, the accounting policies listed below remain relevant. This change is purely presentational to meet the requirements of IAS 1 and does not represent any uncertainty in the Company's ability to meet its remaining obligations as they fall due. These policies have been consistently applied to all years presented, unless otherwise stated. The financial statements are presented in sterling, which is the Company's presentation and functional currency. The Company has not used any significant estimates or judgements in preparing the financial statements in conformity with IFRS.

Share capital

Shares are classified as equity when there is no obligation to transfer cash or other assets.

CHANGES IN ACCOUNTING POLICIES

As the Company is dormant, there are no changes to accounting standards that are expected to have an effect on the financial statements. This applies both to changes in IFRSs effective in the current year, and those issued but not yet effective.

3. Statement of comprehensive income

The Company has not traded or made profits or losses during the year ended 31 December 2021. Therefore, no statement of comprehensive income has been prepared.
