#### **OPINION**

In our opinion the financial statements:

### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2017

### 1. GENERAL INFORMATION

Heron Quays (HQ4) Limited is an English Limited Company registered at One Canada Square, Canary Wharf, London, E14 5AB.

The nature of the company's operations and its principal activities are set out in the Directors' Report.

### 2. ACCOUNTING POLICIES

## 2.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention and in accordance with United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice, including FRS 102 "the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland").

These financial statements have been prepared under FRS 102, the Financial Reporting Standard applicable in the United Kingdom. In accordance with paragraph 35.10(m) of FRS 102, the financial statements for the year ended 31 December 2016 were prepared under accounting policies retained from the previous UK GAAP.

The adoption of FRS102 has resulted in no material adjustments to the accounting policies used by the company.

The preparation of financial statements in compliance with FRS 102 requires the use of certain critical accounting estimates. It also requires management to exercise judgement in applying the company's accounting policies (see Note 3).

The principal accounting policies have been applied consistently throughout the year and the preceding year and are summarised below:

### 2.2 Statement of comprehensive income

The company has no realised or unrealised profits or losses for the period and has accordingly not produced a statement of comprehensive income.

### 2.3 Statement of changes in equity

There have been no changes to equity and accordingly the company not produced a statement of changes in equity.

### 2.4 Cash flow statement

The company had no cash flows during the year and has accordingly not produced a Cash Flow Statement.

### 2.5 Investments

Investments in subsidiaries are stated at cost less any provision for impairment.

Income from investments is recognised as the company becomes entitled to receive payment. Dividend income from investments in companies is recognised when received or irrevocably declared.

## 2.6 Financial instruments

The directors have taken advantage of the exemption in paragraph 1.12c of FRS 102 allowing the company not to disclose the summary of financial instruments by the categories specified in paragraph 11.41.

## 2. ACCOUNTING POLICIES (CONTINUED)

### Trade and other receivables

Trade and other receivables are recognised initially at fair value. A provision for impairment is established where there is objective evidence that the company will not be able to collect all amounts due according to the original terms of the debtor concerned.

### Trade and other payables

Trade and other creditors are stated at cost.

### 3. CRITICAL ACCOUNTING JUDGEMENTS AND KEY SOURCES OF ESTIMATION UNCERTAINTY

The preparation of financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Although these estimates are based on management's best knowledge of the amount, event or actions, actual results ultimately may differ from those estimates.

For the year ended 31 December 2017, there were no items which the directors believe are significant to the financial statements.

### 4. AUDITORS' REMUNERATION

Auditor's remuneration of £800 (2016 - £Nil) for the audit of the company for the year has been borne by another group undertaking.

## 5. EMPLOYEES

The Company has no employees other than the directors, who did not receive any remuneration (2016 - £NIL).

### 10. POST BALANCE SHEET EVENTS

On 29 March 2018, Stork Holdings Limited, a direct subsidiary of Stork HoldCo L.P., listed its shares on The International Stock Exchange in Jersey and the group headed by Stork Holdings Limited, which includes the company, converted to a REIT.

### 11. CONTROLLING PARTY

The company's immediate parent undertaking is Heron Quays Holdings (HQ4) Limited.

As at 31 December 2017 the smallest group of which the company is a member and for which group inancial statements are drawn up is the consolidated financial statements of Canary Wharf Group nvestment Holdings plc. Copies of the financial statements may be obtained from the Company Secretary, One Canada Square, Canary Wharf, London E14 5AB.

The largest group of which the company is a member for which group financial statements are drawn up s the consolidated financial statements of Stork HoldCo LP, an entity registered in Bermuda and the Itimate parent undertaking and controlling party. Stork HoldCo LP is registered at 73 Front Street, 5th Floor, Hamilton HM12, Bermuda.

Stork HoldCo LP is controlled as to 50% by Brookfield Property Partners LP and as to 50% by Qatar nvestment Authority.

The directors have taken advantage of the exemption in paragraph 33.1A of FRS 102 allowing the ompany not to disclose related party transactions with respect to other wholly-owned group companies.
