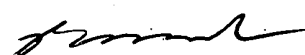
The directors do not recommend the payment of a dividend.

1 Basis of preparation and transition to FRS 102

The company has remained dormant since 1 January 2014, the date of adoption of FRS 102, to the end of the current reporting period. As permitted by FRS 102 the directors have elected to continue to apply the accounting policies adopted under the previous UK GAAP until such time as the company ceases to be dormant. Accordingly there are no transitional adjustments to FRS 102 in the current period.

The financial statements continue to be prepared on the historical cost basis and are presented in sterling.

2 Profit and loss account

No profit and loss account is presented with these financial statements because the company has not received income, incurred expenditure or recognised any gains or losses during either the year under review or the preceding financial year. There have been no movements in shareholders' funds during the year under review or the preceding financial year.

4 Controlling parties

The company is a subsidiary undertaking of Andrews Sykes Investments Limited, a company registered in England and Wales.

The consolidated financial statements for this group are available to the public and may be obtained from the aforementioned address.

As at 4 September 2017, EOI SYKES Sarl, which is incorporated in Luxembourg, held 86.08% of the ordinary share capital of Andrews Sykes Group plc and is therefore that company's immediate parent company. The ultimate holding company is the Tristar Corporation, a company incorporated in The Republic of Panama. The Tristar Corporation is held jointly, in equal proportions, by the Ariane Trust and the Eden Trust and therefore the director considers these trusts to be the ultimate controlling parties of the company.
