## Part 1 - form of the assistance:

The assistance will take the form of the execution and delivery by the Company of the following document (or the documents referred to therein or relating thereto) as the same may be amended, increased, novated, and/or replaced, varied supplemented or substituted from time to time, and the Company fulfilling its obligations under them and/or the entry into of the following transaction:

- 1. a deed of novation to be entered into by the Company (1) Topland Hotels (Hyde Park) Limited, Topland Hotels (Piccadilly) Limited, Topland Hotels (Bloomsbury Park) Limited, Topland Hotels (Euston) Limited, Topland Hotels (Barbican) Limited (the "Target Companies") (together with the Company the "Hotel Companies") (2) Topland Riversmeet Limited, Topland Valley Limited, Topland Medway Limited, Topland Summit Limited, Topland Tor Limited, Topland Delta Limited (the "Purchasers") (3) the Bank (4) and the Hedging Counter-Party (5) (the "Deed of Novation"); and
- a hive-up agreement between the Company and Topland Riversmeet Limited (the "Hive-Up Agreement");

#### Part 2 - principal terms of the assistance:

The principal terms on which the assistance will be given are as follows:

- 1. under the Deed of Novation (amongst other things) all of the Company's benefits, obligations and liabilities to the Bank under the credit agreement (entered into by the Bank (1) the Hotel Companies (2) the Purchasers (3) and Topland Group Holdings Limited (4) relating to the provision by the Bank to the Hotel Companies of facilities in the aggregate sum of £170,000,000 dated 28 April 2005) (the "Credit Agreement") and the Fees Letter (as defined in the Credit Agreement) are novated to the Purchasers; and
- 2. Under the Hive-up Agreement (amongst other things) the property at The Thistle Hotel St James Centre Edinburgh London registered at the Land Registry under Title Number MID22327 is to be transferred to the Purchaser on the terms set out therein.
