

- Not without the previous written consent of the Bank to grant or accept a surrender of any lease or licence of or part with or (b) share possession or occupation of the Company's freehold and leasehold property or any part of it.
- To pay into the Company's account with the Bank (and if more than one then into such account or into such account with (c) another bank) as the Bank may specify from time to time all money which the Company may receive in respect of the Company's book debts and other debts and not to deal with the Company's book debts and other debts otherwise than by collecting them in the ordinary course of the Company's business and in particular not to realise the Company's book debts and other debts by means of block discounting, factoring or the like.
