IT IS ORDERED THAT:-

- In respect of those Bankruptcies, Compulsory Liquidations, Creditors' Voluntary Liquidations ("CVLs") and Members' Voluntary Liquidations ("MVLs") listed in Schedules 1 to 4 attached to this Order ("the Schedules") which are the subject of proceedings in the County Courts, other District Registries and Royal Courts of Justice, those proceedings be transferred to the High Court, Leeds District Registry, solely for the purpose of hearing the application for the Orders contained in paragraphs 2 to 11 below
- The Applicant be removed from office of the estates of the individuals listed in section 1 of Schedule 1 for whom he is the Sole Appointee as Trustee in Bankruptcy which will be transferred to the Respondent as Sole Appointee and the Respondent shall replace the Applicant as office holder with immediate effect.
- The Applicant be removed from office of the estates of the individuals listed in section 2 of Schedule 1 for whom he is the Joint Appointee as Trustee in Bankruptcy and the existing Joint Appointee will continue to act as Sole Appointee with immediate effect.
- 4. The Applicant be removed from office of the estates of the companies for which he is the Sole Appointee as Liquidator listed in section 1 of Schedules 3 and 4 which will be transferred to the Respondent as Sole Appointee and the Respondent shall replace the Applicant as office holder with immediate effect
- The Applicant be removed from office of the estates of the companies for which he is the Joint Appointee as Liquidator (both Compulsory and Voluntary) listed in Schedule 2 and section 2 of Schedules 3 and 4 and the existing Joint Appointee will continue to act as Sole Appointee with immediate effect.
- 6. The Respondent shall be entitled to:-
 - Publish in the Gazette one composite notice relating to all new appointments which are required by law to be published in the Gazette;
 - Apportion the costs of the said composite Gazette notice between those estates with sufficient funds to discharge the costs of this notice in full equally, and
 - 6 3 Charge to each individual estate the costs of obtaining an Insolvency Practitioner's licence bond in respect of that estate.

- 7 The Applicant shall be granted his release as appropriate 21 days after the publication of the notice in the Gazette referred to at paragraph 6 1 above.
- 8. Notwithstanding Rule 6 78A of the Insolvency Rules 1986 in respect of the Bankruptcies listed in Schedule 1, Rule 4 49B in respect of the Compulsory Liquidations listed in Schedule 2, and Rule 4 49C in respect of the CVLs and MVLs listed in Schedules 3 and 4 -
 - The Applicant, as outgoing office holder, shall not be required to prepare a report to creditors made up to the date of this Order; and
 - 8.2 The reporting periods and anniversaries in respect of all of the estates of individuals and companies listed in the Schedules shall end on the same day as they would have ended had this Order not been made.
- Without incurring any additional expenses to any of the said estates, the Respondent shall, when the next routine report is due to the creditors of each estate, notify each creditor of the making of this Order, such notice to contain the following matters.-
 - 9.1 An explanation of the effect of the Order;
 - 9 2 Express reference to the liberty to apply contained in paragraph 10 below,
 - 9.3 In the case of CVLs and Bankruptcies under the Insolvency Act 1986 where liquidation of creditors' committees have been appointed, an explanation that (to the extent that any information which would otherwise be required to be provided under Insolvency Rule 4 108(3) or Rule 6.126(2) has not already been provided as part of the routine report) it is open to that committee to require the Respondent to provide an account of the administration of the estate, including:
 - 9 3 1 a summary of receipts and payments, and
 - 9.3.2 a statement that the Respondent has reconciled his accounts;
 - 9.4 In the case of CVLs and Bankruptcies under the insolvency Act 1986 where no liquidation or creditors' committees have been appointed, an explanation that (to the extent that such information has not already been provided as part of the routine report) it is open to that creditor to apply to Court for an order that the Respondent do provide such information as might otherwise be required by Rule 4.108(3) or Rule 6.126(2) (as the case may be);

- Notification that if the Respondent has been required to provide information referred to in paragraphs 9.3 or 9.4 above, whether by liquidation, creditors' committee or by Court Order on the application of any individual creditors, the Respondent's costs of so complying will, unless there are good reasons to the contrary, be paid as an expense of the Bankruptcy or Liquidation as the case may be,
- In the case of Liquidations under the Insolvency Act 1986, notification to each creditor and member of his/her right under Rule 11(2) (voluntary winding up) of the Insolvency Regulations 1994 to require the Respondent to supply a statement of receipts and payments free of charge; and
- 9.7 In the case of Bankruptcies under the Insolvency Act 1986, notification to each creditor of his/her right under Rule 25 of the Insolvency Regulations 1994 to require the Respondent to supply a statement of receipts and payments free of charge
- Liberty to each creditor of each estate to apply to vary or discharge this Order within 21 days of receipt of the notices directed to be sent under paragraph 9 above
- The costs of this application (including VAT) be aggregated and apportioned equally between each of the estates listed in the Schedules provided that if the costs which fall to be borne by any of the estates exceeds 10% of the realisable assets within that estate:-
 - 11.1 That estate shall only bear part of those apportioned costs, that part being an amount equal to 10% of that estate's readily realisable assets, and
 - 11.2 The excess shall be apportioned and borne rateably amongst the other estates in proportion to their realisable assets
- 12. Following the Orders made in paragraphs 2 to 11 above, the Bankruptcies, Compulsory Liquidations, CVLs and MVLs referred to in the Schedules be transferred back to the respect County Courts, District Registries and Royal Courts of Justice, as the case may be.
- 13. Service of the said Application Notice be dispensed with
