SECURITY ACCESSION DEED

THIS SECURITY ACCESSION DEED is made on 25 September 2019

BETWEEN:

- (1) **THE CHARGORS** listed in Schedule 1 (each person being a "**New Chargor**"); and
- (2) **LUCID TRUSTEE SERVICES LIMITED** as trustee for each of the Secured Parties under and as defined in the Intercreditor Agreement (the "**Security Agent**").

RECITAL:

This deed is supplemental to a debenture dated 30 July 2019 between the Chargors (as defined therein) and the Security Agent (the "**Debenture**").

NOW THIS DEED WITNESSES as follows:

1. INTERPRETATION

1.1 Definitions

In this deed:

"**Excluded Accounts**" means any accounts opened or maintained by a New Chargor which operate to provide cash collateral to a third party and are (i) specified in Schedule 6 (*Excluded Accounts*) of this deed, or (ii) notified by the Parent to the Security Agent as Excluded Accounts **provided that** if at any time the cash amounts held in such accounts exceeds £450,000 (or its equivalent in other currency or currencies) or such other amount as may be agreed between the Parent and Agent (acting on the instructions of the Majority Lenders) in aggregate, each account together with the cash amounts held in each account shall not be excluded from clause 2.3(a) (*Specific Security*) and clause 2.4 (*Floating charge*) of this deed.

1.2 Terms defined in the Debenture

Capitalised terms defined in the Debenture have, unless expressly defined in this deed, the same meaning when used in this deed.

1.3 Construction

Clauses 1.2 (*Terms defined in the Intercreditor Agreement*) to 1.3 (*Construction*) of the Debenture will be deemed to be set out in full in this deed, but as if references in those clauses to the Debenture were references to this deed.

2. ACCESSION OF NEW CHARGORS

2.1 Accession

Each New Chargor agrees to be a Chargor for the purposes of the Debenture with immediate effect and agrees, subject to the terms of this deed, to be bound by all of the terms of the Debenture as if it had originally been a party to it as a Chargor.

2.2 Covenant to pay

Each New Chargor covenants with the Security Agent that it shall, on demand of the Security Agent pay, discharge and satisfy the Secured Obligations in accordance with the terms of the Debt Documents.

2.3 Specific Security

(a) Each New Chargor, as continuing security for the payment of the Secured Obligations, charges in favour of the Security Agent the following assets, both present and future, from time to time owned by it or in which it has an interest:

- (i) by way of first fixed charge, all of its rights, title and interest in and to:
 - (A) its Real Property and all Related Rights;
 - (B) its Tangible Moveable Property and all Related Rights to the extent not charged pursuant to paragraph(a)(i)(A) above);
 - (C) its Accounts and all Related Rights;
 - (D) its Monetary Claims other than any claims which are otherwise subject to a fixed charge or assignment (at law or in equity) pursuant to this deed) and all Related Rights (to the extent not already charged under this paragraph (a)(i)(D));
 - (E) its Investments and all dividends, interest and other monies payable in respect of those Investments and all Related Rights (whether derived by way of redemption, bonus, preference, options, substitution, conversion, compensation or otherwise);
 - (F) its Shares and all dividends, interest and other monies payable in respect of those Shares and all Related Rights (whether derived by way of redemption, bonus preference, options, substitution, conversion, compensation or otherwise);
 - (G) its Intellectual Property and all Related Rights;
 - (H) any goodwill, rights and claims in relation to the uncalled capital of each New Chargor;
 - (I) (to the extent not validly and effectively assigned pursuant to paragraph (ii) below) each Relevant Contract and each Insurance Policy of each New Chargor and all Related Rights in relation to those assets; and
 - (J) Real Property acquired by it after the date of this deed,

but excluding, for the avoidance of doubt, its rights, title and interest in and to any Excluded Assets, Excluded Shares, Excluded Accounts and/or Excluded Property.

- (ii) by way of assignment by way of security (subject to a proviso for reassignment on redemption), all of its rights, claims, title and interest in and to the proceeds of each:
 - (A) Insurance Policy of each New Chargor and all Related Rights; and
 - (B) Relevant Contracts to which each New Chargor is a party and all Related Rights.

2.4 Floating charge

- (a) Each New Chargor charges by way of first floating charge in favour of the Security Agent all its present and future assets and undertakings other than any Excluded Assets, Excluded Shares, Excluded Accounts and/or Excluded Property.
- (b) The floating charge created pursuant to paragraph (a) above shall be deferred in point of priority to all Fixed Security validly and effectively created by each New Chargor under the Debt Documents in favour of the Security Agent as security for the Secured Obligations.
- (c) The floating charge created by this Clause is a **qualifying floating charge** for the purpose of paragraph 14 of Schedule B1 to the Insolvency Act 1986.

3. CONSENT OF EXISTING CHARGORS

The existing Chargors agree to the terms of this deed and agree that its execution will in no way prejudice or affect the security granted by each of them under (and covenants given by each of them in) the Debenture.

4. CONSTRUCTION OF DEBENTURE

The Debenture and this deed shall be read together as one instrument on the basis that references in the Debenture to "this deed" or "this Debenture" will be deemed to include this deed.

5. NOTICES

Each New Chargors' address details for the purposes of notices are as set out opposite its name in Schedule 1.

6. GOVERNING LAW

This deed and all non-contractual obligations arising out of or in connection with it are governed by English law.

7. JURISDICTION

7.1 English Courts

The courts of England have exclusive jurisdiction to settle any dispute (a "**Dispute**") arising out of, or in connection with this deed (including a dispute relating to the existence, validity or termination of this deed or the consequences of its nullity or any non-contractual obligations arising out of or in connection with this deed).

7.2 Convenient Forum

The parties agree that the courts of England are the most appropriate and convenient courts to settle Disputes between them and, accordingly, that they will not argue to the contrary.

7.3 Exclusive Jurisdiction

This Clause 7 (Jurisdiction) is for the benefit of the Security Agent only. As a result and notwithstanding Clause 7.1 (English Courts), it does not prevent the Security Agent from taking

proceedings relating to a Dispute in any other courts with jurisdiction. To the extent allowed by law the Security Agent may take concurrent proceedings in any number of jurisdictions.
