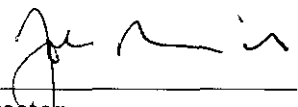
Elective Resolutions

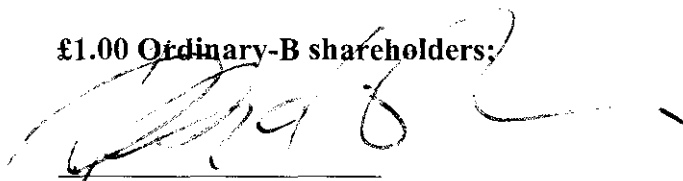
