#### NOTES TO THE ABBREVIATED ACCOUNTS - 30 APRIL 2015

#### 1. ACCOUNTING POLICIES

#### a. Accounting Convention

The Accounts have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

#### b. Turnover

Turnover comprises amounts received and receivable for work done during the year, excluding Value Added Tax.

## c. Tangible Assets

## d. Deferred Taxation
