JOINT ANNNUAL AND FINAL REPORT OF THE LIQUIDATOR TO CREDITORS AND MEMBERS OF THE ABOVE COMPANY PURSUANT TO SECTION 105 & 106 OF THE INSOLVENCY ACT 1986

I refer to my appointment as Liquidator of the above on 30th November 2012 and hereby submit my joint annual and final report regarding my administration of the liquidation in accordance with the Insolvency Act 1986 and Insolvency Rules.

Assets of the company

1. Cash at Bank

The amount of £65,303 was transferred over from the balance held in the Administration I have also recovered a VAT refund on the expenses in the Administration of £16,016

2. Sale of Business

The final balance of £3,352 20 for the sale of business has been paid

3. Book Debts

The book debts were originally being collected by Lloyds TSB Commercial Finance and at the point that the remaining balance of £53,349 was transferred back to me, there was little information and evidence to collect this debt. After discussing this with the new company, I agreed to sell the book debts to Bay Lift Services (UK) Ltd for £3,000. The sale was invoiced and paid for on 23rd July 2013.

4. Sundry Assets

I have also received a refund from Lloyds TSB Cardnet of £831 The only other receipt has been bank interest of £130 22

Unsecured Creditors

Unsecured creditor claims were estimated in the Statement of Affairs at £537,087. I have received unsecured claims to the value of £729,895.

A first dividend payment was made available to unsecured creditors of 8p in the £ on 22nd July 2013 The total amount distributed was £55,876 54

I am now in a position to distribute a second and final dividend to unsecured creditors of 0.72p in the £. The total amount being distributed is £5,051.93

Director's Conduct Report

As required I have submitted my confidential report to the Insolvency Service

Bank Account

I confirm that I have reconciled my receipts and payments with the bank account held at Arbuthnot Latham & Co

Liquidator's Remuneration

My fees were approved in the preceding Administration on 9th February 2012 by creditors on a time cost basis. This continues to apply in the Liquidation. I would advise that Liquidator's remuneration has been fixed by reference to the time properly spent by him and his staff in attending to matters arising in the liquidation. My firm has spent 82.5 hours dealing with the administration incurring total chargeable costs of £19,425 which provides an average chargeable rate of £235.45 per hour. I anticipate fees to closure to be £7,500 and will draw on account of this the sum of £26,925. A detailed breakdown of my time is attached at appendix A.

An unsecured creditor may, with the permission of the Court or with the concurrence of 5% in value of the unsecured creditors (including the creditor in question) request further details of the Liquidator's remuneration and expenses, within 21 days of receipt of this report. Any secured creditor may request the same details in the same time limit.

An unsecured creditor may, with the permission of the Court or with the concurrence of 10% in value of the creditors (including the creditor in question), apply to the Court to challenge the amount and/or basis of the Liquidator's fees and amounts of any proposed expenses or expenses already incurred, within 8 weeks of receipt of this report. Any secured creditor may make a similar application to Court within the same time limit.

The final meeting of members will be held at Kirks, 5 Barnfield Crescent, Exeter, EX1 1QT at 10 00 am on 11th February 2014

The final meeting of creditors will be held at the same location at 10 15 am on 11th February 2014

The main purpose of the meetings are to approve this final report and receipts and payments account and in order that I may seek release as liquidator

In convening the meetings I am required to consider the convenience of creditors. I have no reason to consider that the proposed venue is not a convenient location for creditors. However, should any creditor wish me to reconvene the meeting at an alternative location, please let me know within the next 7 days and I will consider making alternative arrangements.
