1. Introduction

The purpose of this report is to detail the acts and dealings of the Liquidator and it should be read in conjunction with previous reports to creditors.

I was appointed Liquidator of the Company on 22 June 2022.

Since 1 January 2021, I have been licensed to act as an Insolvency Practitioner in the UK by the Institute of Chartered Accountants in England and Wales and prior to that date I was licensed by the Insolvency Practitioners Association. I can confirm that there has been no change in office-holder since the date of the liquidation.

Statutory information regarding the Company is provided at Appendix 1.

2. Progress

Administration

There are certain administrative tasks which I am required to undertake whilst acting as Liquidator of the Company These actions contribute to the efficient running of the estate and are required by statute and regulation. There is no direct financial benefit for creditors.

These include reviewing the circumstances of the case to determine the appropriate strategy, regular reviews of the case and dealing with any post appointment tax matters and HMRC correspondence.

In addition to any of the matters listed below in the asset and investigations sections, during the period covered by this report, I have undertaken a closure review, drafted the closure documents to conclude the case and ensured that all outstanding tax matters have been completed.

Assets

Actions taken in relation to assets may have a direct financial benefit for creditors by way of a distribution to creditors after settlement of properly incurred costs.

According to the Statement of Affairs lodged in these proceedings, there were no known assets to recover during the Liquidation.

I have not identified any assets to recover during my review into the Company's affairs.

3. Investigations

An initial investigation into the Company's affairs was undertaken to establish whether there were any potential asset recoveries or conduct matters that justified further investigation. These investigations included reviewing the changes in the Company's assets and liabilities in the period from its last accounts for the financial period ending 31 May 2020 to the date of Liquidation and a review of the Company's bank statements.

My initial investigations identified some matters of interest which warranted further explanation by the Director of the Company. These queries related to transactions with the Company's director in the period leading up to liquidation, transactions with unknown parties and an unknown business purpose in the period leading up to the liquidation and unexplained changes in the Company's assets between the period of the last accounts and the date of the liquidation.

I received sufficient information from the relevant party to enable me to conclude that these transactions were made for the benefit of the Company and therefore no further action was warranted as no recovery was anticipated in respect of the same.

A report on the conduct of any individuals, who have been directors of the Company in the three years prior to the insolvency, is required to be submitted to the Secretary of State within three months of my appointment. I confirm that this has been submitted, however the content of this report is confidential.

4. Costs and Expenses

A Receipts & Payments Account for the period covered by this report and the Liquidation in its entirety is enclosed at Appendix 2. Receipts relating to asset realisations have been detailed in the progress section above. Information in relation to the costs and expenses of the Liquidation are detailed below.

Pre-Appointment Costs

It was agreed with the board of directors prior to my appointment that my pre-appointment fee in this matter for assisting with the preparation of the Statement of Affairs and the deemed consent procedure to place the Company into liquidation by fixed at £2,250.00 plus VAT. I received the sum of £2,700.00 from the Company prior to my appointment.

The fixed fee is considered to be fair and reasonable as it provides creditors with certainty as to the level of the fee to be charged for this work. Further, the Liquidator considers that the fee is commensurate with the amount of work required to carry out these activities in their professional experience.

Liquidator's Remuneration

I have not agreed the basis of my post appointment remuneration during the Liquidation.

My time costs for the period 22 June 2023 to 9 February 2024 total £2,265.00 represented by 6.80 hours at an average hourly rate of £333.09. A breakdown of these time costs is enclosed at Appendix 3.

My time costs for the period since my appointment total £8,465.00 represented by 28.80 hours at an average hourly rate of £293.92. A breakdown of these time costs can be seen at Appendix 4.

I confirm that no fees have been drawn to date in respect of these time costs.
