REPORT OF THE INDEPENDENT AUDITORS TO THE MEMBERS OF THE CONNEXION MANAGEMENT COMPANY LIMITED

Opinion

We have audited the financial statements of The Connexion Management Company Limited (the 'company') for the year ended 30 June 2019 which comprise the Income Statement and the Balance Sheet. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 105 'The Financial Reporting Standard applicable to the Micro-Entities Regime' (United Kingdom Generally Accepted Accounting Practice).
